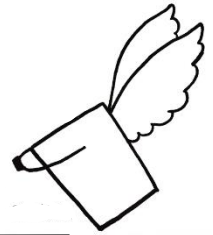

**FOOD:** Will be available onsite for nominal fee. No local areas to eat at. Closest is 7 miles to McDonalds in Lakeville.

**DIRECTIONS** 6952 Harder Road Hemlock, NY – Watch for signs Call Anya's # (585) 478-7060 There will be herding signs out front. \*\* Blank Road is closed and no access to Flying Bucket Farm from there. \*\* See directions below to skirt the Detour from Blank Road.

**NYS Thruway Exit 46 (for I-390 South) from the north, east or west**- Keep right for I-390 South (Corning) 11 miles Exit 10 for Avon/Lima. Turn left onto NY-5/US 20 east. 3 miles turn right onto Livonia Center Road. In 9 miles turn left onto Harder Road. Flying Bucket Farm ½ mile on left. Go past farm to intersection. For those with big rigs – follow across the street to the dead end cul de sac – turn around and go back to the intersection. Entrance to the field will be across the street to the right. If you feel lucky make a U turn in the intersection to make the turn into the field. Easiest to drive down and turn at the cul de sac.

**Coming from the South – I-86 to I-390 North.** About 16 miles take exit 3 for Wayland - NY 15 / Rte 21. ½ mile turn Right onto NY 15N. About 15 miles turn Right onto Big Tree Road. Make a Left onto Federal Road. 3.5 miles turn Right onto Harder Road. Flying Bucket Farm ½ mile on left. \*\*Your gps may want to take you down Adams Road – there is a very sharp up hill left turn onto Federal Rd from there to make. By going to Big Tree you will avoid that intersection.

This is a working farm – please keep away from all livestock. There are free ranging chickens, geese, ducks, cats etc.
