Enter through gate at the end of the driveway to the right, follow the track to handler parking in the training field (see map below). **Warning: gate into trial field may have electric wire running across the bottom. Use plastic handle to open and close wire as needed to enter parking area.**

Start Time each day: 7:45 AM handlers meeting, 8:00 AM first handler at the post.

Order of Classes:

Friday in Novice field: NN1, PN, NN2, RN

Saturday: N2 & N3 in Novice field, Open 1 in Open field, begin Open 2

Sunday: Finish Open 2 in Open field followed by double lift
