The 1985 trial season will culminate this month with the Annual NEBCA Fall Foliage Roundup Championship Trial. This year's trial will be held at the farm of Mike and Pat Canaday in Altamont, NY. The trial will run from noon Saturday, October 19th, through Sunday October 20th, with a roast beef dinner held Saturday evening at the Canadays'.

Each dog must earn entry into this trial by placing among the top ten NEBCA members at three open trials during the current trial season. This year's qualifying dogs and handlers are as follows:

The points you see written after each dog are the total point accumulated this trial season. Each time a dog places in an open trial they are awarded points as follows: 1st--10, 2nd--9, 3rd--8, 4th--7, 5th--6, 6th--5, 7th--4, 8th--3, 9th--2, 10th--1.

At the Championship trial, trophies will be awarded to the top ten dogs according to the points accumulated. This year's NEBCA High Point Champion dog is Rogar Deschambeault's Daisy, and the NEBCA High Point Reserve Champion is Walt Jagger's Dot. At the Championship trial itself, there will be trophies awarded to the top ten dogs placing in the trial, the best outrun, best fetch, best drive, best pen and best shed. These trophies, including those for the top ten high point dogs have been generously donated by this year's trial sponsor, Alpo Pet Food. There will also be a crook, donated by John Hood, for the best gather. Edgar Gould has donated the breeder's trophy, which will go to the breeder of the dog winning the trial. This year's trial programs have been donated by Capitol Tractor of Troy, NY.

As you can see, NEBCA and its events are gaining rapidly in popularity and support. We would like to thank heartily all those who have contributed their time and support to this year's upcoming NEBCA Fall Foliage Roundup Championship Trial. We also extend our congratulations to this years winners of the High Point Champion and Reserve Champion and to all those who have qualified for the Championship trial. We wish you all luck.

Everyone is invited to attend both the trial and dinner (members and nonmembers alike). There is no fee for spectators attending the trial, which starts at 12:00 PM on Saturday, October 19, and 9:00 AM on Sunday, October 20. The dinner Saturday evening will be held at approximately 6:00 PM after the trial stops for the day. The cost will be \$8.00 and includes roast beef and all the fixings. Beverages will be supplied by NEBCA and donations of desert would be appreciated. Directions to Mike and Pat Canadays'-

From the NYS Thruway:

From Exit 24 take first ramp after toll booth to Route 20  
Take right turn onto Route 20 West  
Go 6 miles to Route 146 South

From MASS Pike:

Take exit NY B1  
Take Route 90 West to Albany, look for the Route 20 sign just before  
the Thruway toll booth  
Take Route 20 ramp 1 mile; take a right onto Route 20 West  
Go 6 miles to Route 146 South

From Route I-88

Take Route 20/Duansburg exit  
Take a right at the end of the ramp then left--east on Route 20  
towards Albany  
3/4 of a mile after Route 20 turns into a four lane highway--

Now that we are all on Route 20--go on Route 146 south toward Altamont:

Drive about 2 1/2 miles to Guilderland Center  
Take a left at the Getty gas station traffic light  
Go 1/2 mile, Stop at the stop sign  
Take County 202/Meadowdale Road--across the road, slightly to  
the right  
Bear left at the 'Y' staying on County 202/Meadowdale Road  
The first farm house on the right is Canadays'; Box 365  
There are round bales across the street.

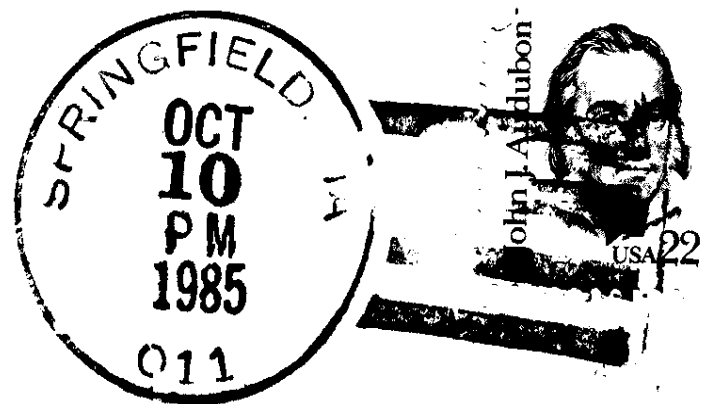
