# MINUTES OF THE ANNUAL MEETING

The meeting was called to order at 10:50 AM, Jan 12, 1986 at Edgar Gould's in Shelburne Falls, MA.

The Secretary's report was read and accepted.

Mike Canaday gave an accounting of calendar sales. He has paid out \$98.20 for advertising, \$92.00 in postage and has a balance of \$820.88 in the account.

Edgar Gould suggested that we all take a few calendars to give away, etc.

Treasurer's report was read and accepted.

#### OLD BUSINESS

Barbara Leverett reported on recommendations made by the trials committee. They were to:

- 1) Change the title of championship trial to "Northeast Border Collie Association Fall Foliage Championship Trial."
  - 2) Change the inscriptions on the trophies to read:
    - a) NEBCA Fall Foliage Championship Trial Champion, year
    - b) NEBCA Fall Foliage Championship Trail Reserve Champion, year
    - c) NEBCA High Point Champion, year
    - d) NEBCA High Point Reserve Champion, year
  - 3) Have awards read:
    - a) NEBCA Fall Foliage Championship Trial, year, and place to 10th
    - b) NEBCA High Point Dog, year, and place to 10th.
- 4) Have recogniton for a Supreme Champion; a supreme champion being a dog that is High Point Champion and Fall Foliage Championship Trial Champion in the same year. This award would be supported by donations from handlers.

5) To deal with a tie for the NEBCA High Point standings, awards would be given for the tied places and the following place(s) would be dropped. In the event of a 10th place tie, all dogs tied for 10th place will receive 10th place.

A motion to accept these five recommendations and to put them into the next newsletter to be voted on by the membership as a separate article in the by-laws was made and seconded. There will be a deadline of twenty (20) days after the newsletter mailing for voting. A lack of response by that date will indicate a positive response.

The Championship Trial this year will be at the Canaday's farm in Altamont, NY. Fran Wheeler volunteered to do Public Relations for the Championship Trial.

The trials committee suggested looking into trying to set up a way for somebody to be able to hire NEBCA expertise and equipment to put on a trial, puppy day, etc. They also suggested investing in some fence to be available to those putting on trials, etc. Mike Canaday was appointed chairman of a committee to look into the feasibility of helping to put on trials. Crawford Taisey and Roger Deshambeault were appointed to the committee. The fencing will be looked into by the trials committee. Maybe we can find someone to donate it.

Mike Canaday announced that Alpo has some very good deals on dog food, and it would be good doing business with them for sponsoring the Championship Trial.

Barbara Leverett gave an accounting of the Championship trial.

## NEW BUSINESS

The newsletter got a lot of great recommendations and the general concensus was to keep it going as is.

Cheryl Jagger moved to include a breeders name in any NEBCA affiliated breeders list for an annual fee of \$10.00. Crawford seconded the motion and it was passed.

Walt Jagger moved to continue with a 1987 calendar. Fran Wheeler seconded the motion and it was passed. A new calendar committee was appointed with

Denise Leonard as chairperson, and Kristen Whittle and Becky Peterson as the other two members. The idea of having a picture of the top ten dogs in the picture for October was discussed.

A list of dates for trials and clinics was made. (It is listed in the Trials and Clinics section of the newsletter and is omitted here as a space saver. ed.)

Membership renewals will be due by March 1st so that the secretary can get a membership list together and out to members before the trial season.

There was a discussion about the classifications of novice trials. A puppy is classified as being under two years old. A novice-novice is where both the dog and handler are beginners and the dog has never placed in the top 10. The course is an outrun, fetch and pen. Pro-novice is where the handler or the dog is a beginner, and the course consists of a outrun, fetch, one drive and a pen. In the ranch class, the dog can't have finished in the top ten, and the course is a whole trial course. In open ranch, the course is a whole trial course, but bigger. There are no sheds.

Edgar Gould announced that the American Border Collie Registry gives \$.50 back to the club for every puppy registration within our area.

If anyone has information for the newletter, please let Kristen and Denise know two months in advance of when you want it printed. (See announcements, ed.)

Walt Jagger moved to hold the next meeting on May 3rd at the U Conn trial. Kristen seconded this motion and it passed. Thanks to Edgar and Helen Gould for being such wonderful hosts.

Dayle Hamilton moved to adjourn; everybody seconded!, passed and the meeting was adjourned at 2:50 PM.
