#### **MEETING MINUTES**

CUMMINGTON, MA SHEEP & WOOL FESTIVAL May 26, 1990

Meeting was called to order by President Steve Wetmore at 4 p.m.

It was reported that the new bylaw passed with no opposition:

"A Trials Committee consisting of six members and the President of the Association will act to regulate, oversee, and help schedule Qualifying Trials, and to set criteria for the management of the High-Point System and the Fall Foliage Championship Trial.

The six members will be appointed by the President with two members serving one-year terms, two serving two years and two serving three years on a rotating basis. No more than two members will have their terms expire at the same time.

At the end of a member's term, he may be reappointed, if willing to serve again."

#### **Pamphlet**

The members present were asked to come up with ten reasons to join NEBCA - these will be added to the back of the pamphlet. Beverly Lambert will 'polish' the list

and have 2000 pamphlets reprinted.

- 2) NEBCA puppy days free to members
- 3) Newsletter (training articles, ads, etc.)
- 4) Promotes the working Border Collie

  - 8) Nursery trial system
- 9) Contacts with sheep people
- 10) Contact with all of the great Border Collie people

#### **Calendars**

Steve reported that the 1991 NEBCA calendar is available. Costs are as follows: less than 10 calendars are \$6.00 each, 10-20 calendars are \$5.00 each, 20 or more are \$4.00 each. Individual calendars are \$6.00 + \$1.00 postage through Steve Wetmore or calendars can be purchased at most trials.

Steve reported that an invitation has been sent to Patty Rogers, Secretary of the American Border Collie Association to invite the ABC to the NH Championship on September 29 for their annual

meeting. No reply has been received as yet.

#### **Futurity**

The Futurity will be held at Fern Hall (to be approved by the Trials Committee) during the Fern Hall trial. There will be three runs and the judge will be the same as the Fern Hall trial judge. There are 5-6 dogs entered in the Futurity and Bev wants NEBCA to pay for the Futurity so that the Futurity can pay out all of the entries. The Futurity will pay the top two dogs (1/3 entries). It was motioned that NEBCA pay \$300.00. This passed.

There are 12 dogs entered in the 1991 Futurity; the dogs must be born after 9/15/88.

#### **Nursery Trial Committee**

Discussion was held on where a dog must run if it runs in a higher class than it has to. As it stands, the dog can move back down as long as it does not place in the higher class. Pertaining Minutes of the Annual Meeting were read by Steve.

Walt brought up that the Canadians would like the wear to become optional in the Novice-Novice Class; they

# CORRECTIONS -- 1990 APPROVED TRIALS

Over the last several weeks, there has been some confusion between these two editors and the Trials Committee. IN THE FUTURE, WE WILL TAKE NO NOTICES OF TRIALS OR PLANNED TRIALS FROM ANYONE BUT THE CHAIRPERSON OF THE TRIALS COMMITTEE.

This piece is intended to set the record straight on all 1990 Qualifying Trials. The Trials Committee has reviewed and approved 34 trials for the 1990 Season. We will continue to post all trials that we know about in the Northeast, but only this list constitutes Qualifying Trials. to move up in the Nursery Trials - again nothing can be done until the Annual Meeting.

The first correction is with the May 19 Open Trial in Ontario. We had been advertising it as a Qualifying trial, and we had counted the points for it in the total Accumulated Points in our last issue. IT WAS NEVER APPROVED AS A QUALIFYING TRIAL. Therefore, the Point Accumulation has been adjusted to reflect this fact.

Second, the trial known as Willow Bend, held in London, Ontario on June 2 & 3 had been advertised as a Qualifying Trial. The results are reported in this issue. The Trials Committee met on July 7 to discuss and decide on its qualification. By all reports, the trial was not well managed. In addition, only 4 dogs ran on Saturday and one dog on Sunday. The Commit-

tee decided to disqualify the results of both trial days. Therefore, the Accumulated Points do not reflect the results of this trial.

Although the date of this trial has not been changed, its name, location, and trial manager have changed (see list of trials). The Trials Committee has ruled that these changes are enough to disqualify it for NEBCA Points. Therefore, it will not be an approved trial for the 1990 Season.

#### Editor's continued

Perhaps, it is time to exercise my editorial privilege and print the opinion I have been so vocal about to the Trials Committee. I reject the logic that led to the disqualification of both Willow Bend and Prince Edward County (formerly Sheep Focus)

Willow Bend was disqualified, after it was run, on the grounds that it was poorly run and that there were too few competitors. Doesn't it seem unfair that the competitors are the ones that have lost their NEBCA points as a

result of this decision, but that they had no control over the factors leading to the decision? More importantly, it is this editor's opinion that TALL GRASS AND LOUSY SHEEP do not disqualify a trial. Additionally, a "minimum number of dogs" restriction was proposed at our annual meeting and rejected then. How can there now be a unilateral decision that there were too few dogs at this trial? Since the judging was good and there were no irregularities, Willow Bend should NOT have been disqualified.

Prince Edward County is another matter. Since it has been advertised throughout the year as Sheep Focus, run by Amanda Milliken and it is now Prince Edward County run on a different farm by Pat and Roxanne Buckley, it can be argued that there has not been enough time to check it out. However, since Amanda is a part of setting up the trial and has had a whole lot of experience with running trials, it would seem to this editor that we could have been a bit more accommodating to our Ontario Border Collie Club members. Prince Edward County should have been a qualified trial.

Much of this confusion and dispute has been caused by a lack of communications, and it could have been avoided. It is why I will insist in the future that all information on future trials come to us via the Trials Committee. The trial results are still the responsibility of the Trial Manager, but, if you want your trial to be an approved NEBCA Points Trial, it MUST go through the Trials Committee.

#### **KEYSTONE STATE STOCKDOG TRIALS** June 23 & 24, 1990

Sheep used were Reg. Suffolks, Suffolk lambs, Reg. Montadale ewes. Weather was quite hot and humid on Saturday with a mild breeze on Sunday to temper the heat. Course was a rectangular, flat pasture yielding a 120 yd. outrun for the Open Class. Pressure was confined to just one corner of the field which contained both the holding and exhaust pens. Sets of three sheep were given to each handler, two ewes and a lamb. Advertising in local newspapers brought a crowd of about 150 to 200 on Sunday. Promotional booths were attended by Dad's and Nutro-Max. A tent was provided for the spectators.

On Saturday a lecture on the Effects of Heat Stress on Working Dogs was offered at the lunch break. A knowledgeable researcher, Robert Downey, from Annamaet Dogfood in Sellersville, PA gave a well-attended and informative discussion on how dogs react physiologically to heat while working, and how to prevent and treat heatstroke.

A concession wagon was available throughout both days by the Dublin Lioness Club. The Marschark's 1-1/2 acre pond was available to cool off both dogs and handlers as well.
