# ALLEGHENY PLATEAU SHEEP AND WOOL FESTIVAL TRIAL

This was the first trial held in conjunction with a medium size sheep and wool festival held in rural, Central New York. Used to having demonstrations as part of their celebration, they were unprepared for the large response to an actual trial. In addition, due to a number of confusing issues, it almost seemed like the trial was not to be, as the site was cancelled on Thursday before, and then reapproved by Saturday morning. But the show must go on, and go on it did!

The trial started in the infield of a harness racing track at 10:00 a.m. The sheep were not allowed to cross the track before

that time, so there was no way to get them accustomed to their temporary location. This resulted in spooky, running sheep, with dogs needing to be on their toes and quick. Later, as the sheep got more accustomed to the routine, they became quite heavy and belligerent, and the dogs had to work to move them. Penning was not easy, but was possible.

The good-will spread by this competition is unmeasurable! Skeptical fairground site owners were impressed by the professionalism displayed by all-competitors, sheep handlers, dogs, etc. The Sheep and Wool Co-Op were pleasantly sur-

- It is a democratic, non-profit organization.
- A portion of all registration fees is available to each state for Border Collie promotion purposes; the amount being directly related to the number of registrations from that state.

Every year the ABC holds its annual meeting in a different area of the country; in this way the Association actually comes to its members. Due to the efforts of Beverly Lambert and Roger Deschambeault, it was arranged for the ABC to come to NH for this year's annual meet-Kathy and Roger ing. Deschambeault graciously agreed to have their New Hampshire State Championship Trial host the meeting. So Saturday evening after a delicious dinner in the local Grange Hall, instead of the usual music and frivolity, the 1991 annual meeting of the ABC was called to order by President Robert Barlow who lives in Tennessee. The ABC Secretary-Treasurer, Patty Rogers from Mississippi was with him. Together they ran an excellent meeting, with President Barlow doing a great job of trying to give everyone who had something to say a chance to say

## O'BRAE FARM TRIAL

Held in a large, wide open, basket-valley field in the hills of Central New York, the morning runs had to contend with hard rain, afternoon with humidity, haze and building heat. Except for some of the older girls, the sheep (mixed groups of Corriedales Montadales, Tunis, ewes and lambs), moved better on their home turf. A test for the dog, they were not impossible to handle.

This somewhat large course used the natural terrain as much as possible. Two trees provided the fetch panels, the first drive panel was out on a peninsula formed by the intersection of two swales, and the entrance of the pen was centered directly over a (large) woodchuck hole! The sheep were easy to hold, and easily seen from the post. Outrunning to either side, the dog lost sight of the sheep while going around behind. Sometimes a dog came "up", somewhat off balance. "Fence runners" were picked up in the next county!

By the end of the day, everyone was talking about "next year", except maybe our hosts who need some time to recuperate!

### **BREEDERS DIRECTORY**

The Breeders Directory runs from January 1 through December 31. The enrollment period for all renewals or new listings for 1992 is November 1, 1991 through January 15, 1992. 

## DIRECTIONS TO ANNUAL MEETING

The Northeast Border Collie Association will hold its AN-NUAL MEETING this year in Guilderlands Center at the Frederick House. The meeting is scheduled for January 11, 1992, but, should it snow enough to make driving treacherous, it will be postponed until January 25, 1992. The meeting will be called to order at 10:00 AM SHARP. Please bring a covered dish of your choosing (include serving utensils, also) to share for lunch. Coffee will be available.

If anyone has questions on the directions that follow, please call Mike or Pat Canaday (518)861-6049:

#### FROM THE EAST:

Get to Route 190 heading West from Route 191 or any other appropriate route. Take Route 190 west to Exit B1. There should be a sign that points you to the continuation of 190 towards Albany, Rensselaer, Hudson. Go towards Albany. Get off at Exit 1S, the last exit just before the toll booth at the New York Thruway. Get on Route 20 heading West and follow the directions below:

#### FROM THE NORTH:

Get to 187, also called the Northway, North of Albany and head South. Stay on the Northway until it ends at Route 20. Be careful as you approach the intersection with 190, because there will be a sign that says "EXIT HERE FOR 87". DON'T!! Stay to the left at that sign and follow the signs for CROSSGATES MALL ROAD & ROUTE 20. Continue to follow the signs for Route 20, get on Route 20 heading west and follow the directions below:

FROM THE WEST VIA ROUTE 188:

Get to Route I88 and head west. Get off at the Duanesburg/Route 20 exit. Turn right onto the ramp and then left onto Route 20. Go East on Route 20 for about 5 miles to Route 158. Turn right on Route 158 and

continue until Route 146. Turn left on Route 146. Take Route 146 to the traffic light. The Frederick House is the first house on the left after the traffic light. Park in the parking lot of the new church immediately after the Frederick House.

#### FROM THE SOUTH:

Take the New York Thruway North to Exit 24. Right after the toll booth, the Route 20 ramp goes off to the right. Go up the ramp and turn right onto Route 20. Head West on Route 20 and follow the directions below: FOR TRAVELERS HEAD-ING WEST ON ROUTE 20:

Take Route 20 West past the Crossgates Mall for 5-6 miles to the intersection with Route 146. On your left will be Tommy Polito's Tavern as you approach the intersection and Stewart's across Route 146 from the Tavern. Turn left onto Route 146. Follow Route 146 for about 2 miles up over a Railroad Bridge to the Frederick House on your right. Park in the parking lot of the new church immediately before the Frederick House.
