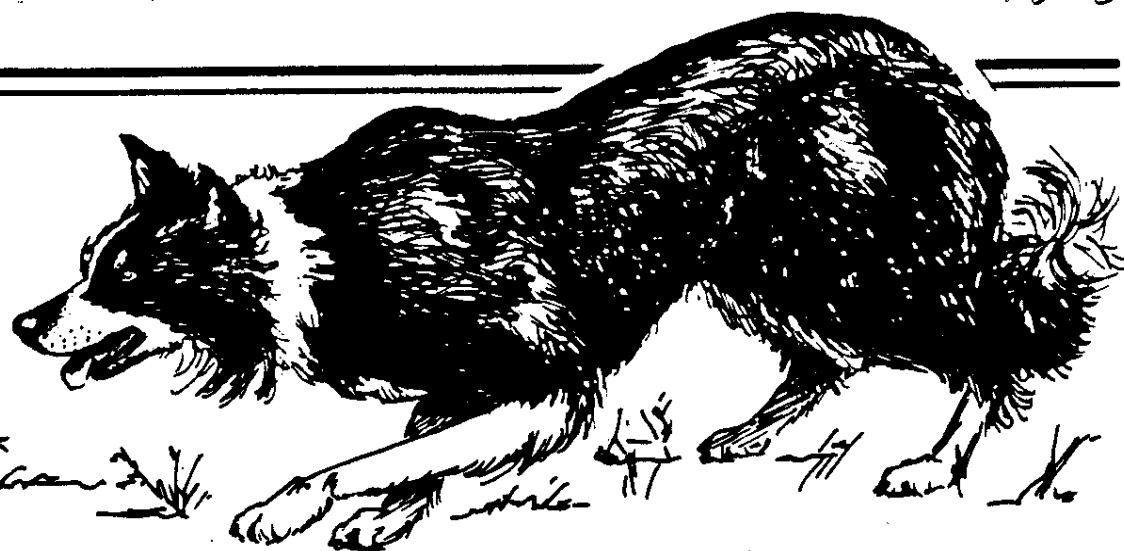

## ANNUAL MEETING AND TRIAL RULES SUPPLEMENT

### President's Message - 1992

Our 1992 Annual Meeting was attended by more than 35 members, which is about ten percent of our total membership. It's this type of involvement and participation that makes NEBCA such an active organization. As NEBCA's membership grows, our Association is involved in an increasing number of activities and projects. All of these projects (the Newsletter, Lending Library, Futurity, to name just a few!) are the result of members input. They all require volunteer time and effort. That they are so successful is a wonderful reflection on our membership.

When an organization such as NEBCA grows, it also must experience changes. Some examples: A) In its early years, NEBCA had no Nursery Trials Committee. After forming several years ago, the Nursery Trials Committee has done an excellent job of setting guidelines and course descriptions that are accepted throughout our region as the standard. This has resulted in more Nursery Trials, and more Nursery Trials Competitors. B) The Open Trials Committee has worked very hard to develop a fair system for the High Points Awards. After making changes, the membership approved their work and we now have a system that

works well. C) The NEBCA Newsletter - a perfect example of change in our club. It has constantly been upgraded and expanded by our present Editors as well as past Editors. At the 1992 meeting, it was voted to provide a regular listing of our NEBCA members who offer Border Collie Rescue Services, something never listed before. I could go on, but I feel I've made my point.

There is something, however, that hasn't changed, and your President and Officers feel it should be addressed. The present NEBCA By-Laws were adopted on March 20, 1983. At that time, NEBCA was a small association of only a dozen or more members. As we have grown, the need to make changes in the By-Laws has become apparent. At the 1991 Annual Meeting, Cheryl Jagger-Williams, Vergil Holland and Doug McDonough volunteered to write a proposal for modification and revision of the By-Laws. They presented their ideas at the 1992 Annual Meeting, and listened to much discussion and input from the members attending. The majority feeling was that we now have a proposal for By-Laws that are better suited to serve NEBCA. These new By-Laws will be presented to the membership for the necessary vote in

## EDITORS' NOTES

We would like to discuss two topics that must dominate this issue -- The Annual Meeting and Border Collie Rescue. The first is what this issue is all about. The second, all too often, gets last page coverage, and the stories we hear would

bring grown men to tears, and they must be told.

**First -- The Annual Meeting.** We had a respectable turnout, but it was all of the very familiar faces. Again we find that a very few are setting the direction for a club of very many. This is always the case with the American Political System, and it appears that it will remain true for our Association. You can only hope that your elected officers are speaking for the voice of their constituents. We encourage you again to write to them to express your opinions.

Most important at our meeting, and not covered in this issue, is the subject of a new set of By-Laws. Cheryl Jagger Williams presented to the members a proposal for a change to

our Association's By-Laws. The proposed changes will be reviewed in our next issue.

The rest of the meeting is covered throughout this issue. Very interesting to these editors was the fact that there were several people at the meeting who were NOT trial people. So, finally, we are getting some Border Collie Handlers who are working their dogs at activities other than on the trial course. We can only encourage all of you to continue to engage in diverse activities with our chosen breed. The versatility of the Border Collie continues to be amazing. Write to us with your experiences so that we can get you into print.

## Second -- BORDER COLLIE RESCUE

Lynn's absence and was accepted as read.

### Treasurer's Report

The Treasurer's Report was read. The balance at present is \$5666.60 and the Futurity account has \$875. Kristen Whittle questioned the amount of money donated toward the ABC trial at Roger Deschambeault's. Steve Wetmore reported that \$350 was approved at the 1991 meeting to be applied towards the judge and trophies. However, there was no accounting of how the money was actually applied. For future such expenditures, it was recommended that there be an itemized accounting of all monies spent.

Walt Jagger and Dick Williams offered to audit the books for the protection of the Treasurer and NEBCA. Walt suggested a bigger committee. Appointed were Walt, Dick, Carol Campion and Lynne Sheninger. They will meet at Gene's trial in late April to audit books. The results of the audit will be published in the Summer issue of the NEBCA News.

There was some discussion on how NEBCA should ap-

prove monies spent. Dee suggested a financial committee to approve money spent. Eve Marschark asked how it was usually handled and felt there should be a listing of receipts for money spent. Steve answered that money issues are brought up at annual meetings for approval. Gene Sheninger suggested following IRS standards to present receipts for anything over \$25. Walt made a motion to accept the Treasurer's Report. The motion was seconded and approved.

### Newsletter

Gene and Lynne Sheninger were thanked for their efforts and labor on the Newsletter. Lynne read a letter from the Tri-State Stock Dog Association that was requesting that NEBCA News publish a listing of their events. Much discussion followed and it was suggested that we charge for such listings. Gene recommended we provide free listings for any event beneficial to Border Collies. The decision was made to give Gene and Lynne the authority to approve and run event listings at their discretion.

Buried in the pages of this issue, you will find a listing of SOME of the Border Collie Rescues in our region. Those that are not listed are kept out at their

The subject of including Border Collie Rescue Services was discussed. Kristen Whittle made a motion to provide a free listing. Cheryl Williams seconded the motion and it was approved. Gene suggested we publish an article on B.C. rescue groups. Lynne Sheninger offered to follow up with the various Rescue Services to solicit an article.

### Pamphlet

The reprinting of the NEBCA pamphlet was addressed. It was decided that it is very worthwhile and that any items subject to change be removed from the main body of the pamphlet. Any items such as dues, Breeders List, Officers addresses, etc. will be maintained on a separate insert that can be changed without changing the entire pamphlet. Kristen

agreed to look into the costs for reprinting. Denise Leonard motioned that the cost to reprint not exceed \$400. Carol seconded and the motion was approved.

### Calendars

Steve reported that he still has a number of 1992 Calendars available. A suggestion was made to remove printing from the cover on future issues of the calendar. On the earlier calendars, only a picture was used so that it was more suitable for framing. It was also suggested that a name, address and telephone number be added for the convenience of people who wanted to reorder for the following year -- passed. Carol made a motion to print 1000 copies but not to exceed last year's cost. The motion was seconded and approved.

### Lending Library

Beverly Lambert wants to step aside after serving several years as NEBCA's "Librarian". Many thanks to Beverly for helping start the Lending Library and for looking after all those books and videos. Lin Reuther volunteered to take over as Librarian and will get a complete list of books and videos to the Editors for printing in the Newsletter. Lin will also look into getting the Glyn Jones training video; if we must pay for it, the money was approved in 1991. ### Futurity

The 1992 Futurity was discussed and funds were requested for the judge and trial expenses. The need for an outside on-site coordinator was

stressed. The group voted not to provide the funds and to table any further discussion until Beverly Lambert is present. The motion was seconded and passed. A committee to reorganize the futurity for 1994 was formed and will meet before the Cummington trial. The committee members are Kristen Whittle, Gwen Cassel and Beverly Lambert.

### Fall Foliage Trial

The location of the 1992 Fall Foliage Trial was discussed. Walt Jagger mentioned that Amanda Milliken had offered a site in Canada but had needed an answer prior to the first of the year. Gene asked about the result of the proposed amendment to the By-Laws to raise the annual dues and that the increase be used to fund the Fall Foliage Trial. Of a possible 431 votes,

138 were returned with 74 votes for and 54 against the proposal. Those not returned are considered a "no" vote. Many ideas was brought up for funding the championship. Some of the suggestions were to charge \$1.00 per dog in all open trials which would generate \$1000 based upon the number of open dogs competing in trials last year; nominate dogs for the championship; charge an entry fee per dog. Vergil Holland made a motion to charge each handler in the championship trial a \$20 entry fee. If no additional sponsor can be found, the difference could be made up by NEBCA. The motion was seconded and approved. A committee for the 1992 championship was formed consisting of Steve Wetmore, Gwen Cassel and Vergil Holland. The 1993 championship committee will be made up of Carol Campion, Denise Leonard and Kristen Whittle. Lynne Sheninger agreed to do the program. Possible sites suggested were Hop Bottom, PA, Strafford, VT and Durham, NY.

Bonnie and Vergil Holland were presented with a beautiful gift by NEBCA for hosting the 1991 Fall Foliage Championship Trial and Futurity - a painting of a Border Collie working sheep.

### Nursery Trials

It was mentioned that a new club has been formed on Cape Cod and they will be holding a series of trials this trial season. A discussion on sanctioning followed and it was agreed that those trials would be approved if the manager was a member of NEBCA and all of our Nursery Trial Guidelines are met. Plaques of achievement were presented to those handlers and dogs who progressed to the next nursery class. There was a discussion on the newly revised nursery points system that was passed last year. It was decided

to make no changes to the nursery points system for 1992.

### Trials Committee

Becky Peterson recommended including in the guidelines that scores at trials be posted every three runs.

Eleanor Jagger agreed to continue to tally the points for the year end high points awards and championship trial.

There was a discussion about disqualification when a handler loses sheep. It was decided that, if a handler loses sheep or walks off the course, it should be a disqualification. A handler running out of time should receive points up to that time.

Dogs gripping sheep would be left up to the judge's discretion.

### New Business

Dee Woessner reported that 473 letters were sent to AKC Member Clubs. Much discussion followed on the AKC issue. Edgar Gould suggested that we ignore the issue but the group disagreed. The ABC warns that the AKC needs no notification of actions. Kristen suggested that the ABC buy other stud registries if they close. Eve suggested that we should obtain legal advice. Kristen made a motion to write to the ABC suggesting they buy other registries. Dee Woessner seconds and the motion is approved. Steve suggested rescinding motion and there is further discussion. Gwen Cassel agrees to write an informative article on the whole issue. Look for a more complete discussion by Gwen in a future issue.

The storage of the NEBCA fencing is brought up and Vergil Holland offers the use of an old trailer. The trailer will be provided to Becky so that she can store the fencing more conveniently. Licensing the trailer for road use, should it be necessary,

will be the responsibility of Becky.

Dee Woessner suggests ads or writeups on NEBCA be run in other B.C. publications and will seek reciprocal ads. Currently there is a reciprocal agreement between NEBCA and The Working Border Collie. No other such relationship exists. Dee will look into making the appropriate arrangements.

Steve Wetmore urged that more puppy days be held free to NEBCA members.

The proposed changes to the By-Laws were presented and discussed. The full proposal will be printed in the next News-letter to be voted on.

A request was made to make the membership list available to members. It was decided that 60 days notice of intent will be printed in the NEBCA News. Anyone not wanting their name

given out must notify the Secretary in writing. Membership list will be given out to fellow members following receipt of a written notice stating that the list will not be sold. Such requests should be sent to the Secretary. Legal advice on this will be sought by Dick Williams to ensure that members legal rights are protected. There will be a nominal fee to cover postage and handling.

Eve Marschark motioned to keep the Nursery Trials Committee a separate entity from the Trials Committee under the Board of Directors. This was seconded and approved. (This will only go into effect if the new By-Laws are approved.)

Dick Williams made a motion to adjourn the meeting. This was seconded and approved.

# NEBCA Nursery Trials Committee Report 1991 Season

This year we have received the fewest number of complaints regarding the Nursery points system ever. It would seem that we have a system that best affords most members a suitable amount of time and opportunity to trial their young dogs. The only complaint that I heard was that we should allot points on a curve instead of an equal division of the upper 50% possible points. This suggestion would make it harder for a dog to accumulate points based on an average performance run (perhaps at the hand of a generous judge), thus avoiding moving a mediocre dog through the class too soon. We felt it would be best to keep things as they are for another year to give it time to work.

We plan to publish copies of the Nursery Guidelines and Recommendations to send to each Nursery handler. Michael Dathe can be contacted at any time for extra copies. Trial managers will also be sent a copy with their Spring Packet and letter along with a form (Denise is preparing) which would make it easier for managers to send in the results of their trials. The main problem we had was that trial managers didn't realize what information we required in order to tally up the points, thus I couldn't prepare a current listing of points earned as I had been able to last year. I would have liked to have been able to provide an updated list at least two or three times during

the season so folks could look up their dogs' points.

In an effort to correct the usual delay of managers sending in results, we will be dividing the responsibilities among the four of us to follow up after each trial. Points will still be tallied by me, but you can expect a call from any of us if you have not sent in your results within ten days. If trials are running a week apart, we may need those results sooner.

The 1991 Points Chart is available at the Annual Meeting to anyone interested in seeing it.

If anyone has any suggestions or complaints, please feel free to contact one of us. We would like to write an informal letter for publication listing any "Unwritten Rules of Etiquette" for handlers (especially new handlers) while participating in a trial. Any suggestions for this article could be given to either Carol or me. Thanks.

We feel it was a successful year for Nursery dogs. We would like to see more trials in 1992! Please consider hosting one this year?!

own request. It seems that they may have more business than they can handle. Some of the Rescues talk about normal dogs that found their way into homes that were ill-prepared to deal with the tremendous energy of the Border Collie; or normal dogs that were causing allergies among family members; or families that had to move to tighter quarters that could not accommodate a Border Collie — all very understandable reasons for people to part with their Border Collie AND most of which were taken back by the original

Breeder as a part of the original contract of sale.

But some of the rescues talk about Border Collies with no eyes, Border Collies that are vicious, Border Collies that are so nervous that they cannot remain calm around people, Border Collies that are born deaf, Breeders who refuse to take back a dog that has not worked out, Breeders who keep many dogs (too many) in tight unsanitary quarters, and Puppy Factories. These Rescues have "Special" Border Collies that require VERY "Special" homes.

These editors will put you in touch with those Rescues if you are that "Special" home, because there are far too many dogs for the available homes. But these Rescues can accept no more Border Collies that come from the few unscrupulous Breeders proliferating Border Collies throughout the Northeast — They are full up with these Breeders' rejects.

In this issue we have changed the heading in the Breeders List to include a mild admonition to BE CAREFUL. NEBCA, the NEBCA NEWS and these editors cannot exclude members from being listed as a Breeder;

nor can we specifically recommend for or against any one Breeder. All we can say is that it is possible for an irresponsible Breeder to be listed and it is your duty to check out your prospective Breeder as thoroughly as you feel is necessary. The Reputable Breeders on the list will be happy to furnish references to anyone intending to use their services. If a Breeder is unwilling to do so, perhaps you should wonder why.

## NORTHEAST BORDER COLLIE ASSOCIATION GUIDELINES FOR QUALIFYING TRIALS

1) Trials must be held in the Northeast Region which will be as follows:

- a) New England States (ME, VT, NH, MA, CT, RI)
- b) New York
- c) New Jersey
- d) Pennsylvania
- e) Canadian Provinces of Quebec, Atlantic Maritime, and Ontario

2) The class may not have a limit of the total number of dogs entered, but may have a limit of dogs per handler. If a high limit does exist, the trial may remain a qualifying trial as long as no NEBCA member from the Northeast Region is turned away before the entry deadline.

3) A trial must have a minimum of 12 Open dogs compet-

ing in the Open class to be a Qualifying Trial.

4) The class will be judged by a qualified person approved by the NEBCA. A list of qualified judges is available from the Association.

5) Judges to judge on a suggested system of 100 points. Some points may change according to certain course changes. A judged trial is preferred but points trials may be accepted.

Outrun 20 Points  
Lift 10 Points  
Fetch 20 Points  
Drive 30 Points  
Pen 10 Points  
Shed 10 Points

Total 100 Points

It is suggested that any dog retiring from or being called off the field for any reason other than running out of time receive a score of "0".

6) Trial managers are requested to post scores of all completed runs at intervals of every 3-5 dogs.

7) Trial dates and intentions to be known before the start of the trial season. The season usually starts in April or May. The trial must be an organized and advertised trial.

8) First time trials will be up to the Trials Committee to approve or disapprove as Qualifying Trials. All trials will be the responsibility of the Trials

Committee to approve or disapprove.

9) The NEBCA Trials Committee has the power to suggest changes to the course and can decertify a trial if conditions appear not to be conducive to the health and welfare of the livestock or the dogs. Two members of the Trials Committee and/or a NEBCA Officer must be present.

10) The trial must have an individual (manager) who must contact a NEBCA Trials Committee member in advance to help insure a successful trial.

Each trial will receive attention from the Trials Committee in a positive, helpful manner.
