### Sussex County Sheep Dog Trials Augusta, New Jersey April 25-26, 1992 Judge: Alf Kyme

Cold, rainy and raw. The weather was more reminiscent of March than the end of April. But the sheep had already been shorn, so they were ready to go. What a weekend for a dog trial.

This year we had a new field for the trial, longer, wider, and much better suited for spectators -- WHAT spectators? A 200 yard outrun and a 100 yard cross-drive made it quite interesting to run sheep that were "a bit" flighty without their winter wool. It was a tough course with tough sheep. At least, they were reasonably consistent for all competitors -- except for the one or two that had a mind of their own.

Once again this year, the Sussex County Sheep Breeders As-

sociation sponsored the trial. They are trying to drum up more interest in sheep and sheep products in northwestern New Jersey, and are doing quite well at it. With their contribution, along with contributions from several national and local companies, there was over \$2000 in prize money paid back to the top ten handlers over the two days.

With a dinner catered by a local caterer on Saturday night and the normal camaraderie that goes along with the New Jersey Trials, the weekend was a success -- in spite of the inclement weather. At least it brightened on Sunday, and some even got sunburned.

NEBCA BY-LAWS -- WE CANNOT STRESS ENOUGH how very important it is that every NEBCA member vote on the proposed changes to the By-Laws. Vote for the amendments or vote against them, but PLEASE VOTE. At this writing, we have still not received enough votes (total) to count. It

is this very problem that our officers are trying to correct with a new set of By-Laws, much more appropriate for the size of our Association. With the proposed change, future revisions to the way our Association operates can be more easily accomplished. Please show them that you really care about NE-BCA and its future. However you vote, for or against, please send in your card.

BORDER COLLIE RES-CUE -- Once again, we feel compelled to tell you of some of the less scrupulous practices of some breeders. We heard about a pup that suffers from Retinal Displasia, another hereditary eye disease. This pup, purchased from a well-known breeder, was totally blind in one eye and partially blind in the other. When the owner of the sire was asked to submit the sire for an eye exam (at a clinic on the grounds of a trial in which he was competing), he refused. This sire was reputed to have covered more than 50 bitches in a single year. Could it be that this well-known breeder was more interested in his stud fees than the future of our breed?

Border Collies are displaced regularly from homes. Some because the family is simply not prepared to deal with their new, energetic pet. But, most distressing is the news that there are a few unscrupulous breeders

out there that are making the Rescues necessary by following an irresponsible breeding program. If you are a Special home, looking for a Border Collie that will need a lot of love and attention, contact the Rescontinued page 5

### NEBCA Nursery & USBCHA Nursery -

### Clarifications

The USBCHA has recently organized a nationwide program to encourage trial managers to host Nursery Trials in which young dogs may compete. The course is a Ranch format and is like ours with the exception that they have an age restriction on the dogs. "Dogs must be thirty (30) months or younger on or before December 31 of the year previous to the Nursery Finals." And, "dogs imported younger than one (1) year of age may run."

A number of trial managers have indicated to the Nursery Trials Committee that they wish to host Nursery Trials that are NEBCA and USBCHA sanctioned. This can be easily done and does not require that you run an extra class for USBCHA although it might be simpler to do so. Your options are:

-to run all three classes for NEBCA and one extra Ranch for USBCHA or

-to run all three classes as you normally would. This is required to sanction your trial for NEBCA. Award ribbons 1st through 5th (as you normally would for NEBCA) in the Ranch Class

-Complete the forms for NEBCA and send to Eve Marschark (as you normally would)

-Complete the paperwork for USBCHA and send to Francis Raley. The way you would figure out points is this:

-delete from the list any dogs who exceeded the age requirement.

-a dog earns a point for every dog in the class he outperforms (any dog that meets the age requirement, not the others)

-only dogs that reside in the district in which the trial is held may earn points, although dogs from other zones may compete against him and be counted in the tally.\*\*

(\*\*This is a USBCHA rule. They have the country divided into zones and NEBCA is made up of three zones. Zone #7 is the New England States, NY, NJ, MD and DE. Zone #6 is PA. Zone #9 is Canada. The reason for this is that only eight dogs from each zone may qualify to run in the Nationals.)

As a trial manager you should first join the USBCHA and read the rulebook. You may be asked to notify them ahead of time of your intentions for sanctioning. I believe your trial is supposed to be advertised as well, but contact them for counsel.

As a handler, you must be a member of USBCHA before you run your dog in order for the points to count.

I would encourage everyone to support the USBCHA by becoming members. I would encourage trial managers to host USBCHA sanctioned Nursery Trials. It is our national organization and, as such, directly represents and promotes the Border Collie. By sponsoring USBCHA sanctioned trials, we are participating in something larger than ourselves and thus contributing to the betterment of the BC and our own organization.
