AKC and Border Collie Defenders Reach Understanding

From the United States
Border Collie Club

After a year of uncertainty about the intentions of the American Kennel Club with regard to the future of America's finest working sheep dog, Border Collie owners and the AKC have achieved an understanding of each other's viewpoints and have established a mutually satisfactory relationship.

At the invitation of Mrs. Bryan Conrad (President of the United States Border Collie Club and Vice President of the American Border Collie Association), John S. Ward, the incoming AKC Board Chairman, attended a sheep herding exhibition at Montpelier, Orange, Virginia on the 25th of July. Mr. Ward has a performance dog background and thoroughly enjoyed the demonstration. Some years ago, before Mrs. Conrad started sheep dog trialing, she competed with her Border Collies in obedience trials and tracking tests, several times under Mr. Ward. Mr. Ward is a highly respected trainer, handler and judge.

During the course of a long and cordial conversation, Mrs. Conrad asked Mr. Ward what the AKC intends to do about the Border Collie. He replied: "Nothing." He also said the AKC plans no change in the status of the Border Collie in the Miscellaneous Class.

In a letter to Mrs. Conrad on July 31, Mr. Ward reiterated the AKC Board's position: "With regard to the status of the Border Collie, the Board of Directors of the American Kennel Club has no plans at this time to change its policies with regard to the breed . . . of course, I cannot speak for my successor nor indeed for future Board actions."

Mrs. Conrad reports: "I was most impressed with Mr. Ward and his courteous attention to our concerns. Since the overwhelming majority of Border Collie owners - those with herding, obedience and companion dogs - wish to maintain the dog exactly as it is, I am pleased that the AKC has honored their wishes. I look forward to resuming our historically productive relationship with the AKC and certainly wish Mr. Ward a long and successful tenure in office."

Lodging: Camping will be permitted at the trial site but no hookups are available. If you need lodging call one of the hotels listed below.



The Bend in the Path

The Haven Farm lies up a steep road in Vermont. The terrain is rocky and difficult to plough, so its natural use is for sheep pasture. Jock Haven had worked the farm for forty years and, because the upper open fields were patrolled freely by coyotes, it was his practice to always bring the sheep down to the farmstead at night. In the morning the ewes would be let out of the yard and driven through the paddock, back to the hill.

Close by the gate of the paddock was a huge boulder and, sometimes, when they preferred to stay below, the flock would use the boulder to escape from the driving dog. The flock would run round and round the boulder, much to the frustration of Jock and his Border Collie, Shep. Before too long Jock and Shep figured out that the best countermeasure was for Shep to hide on the other side of the boulder as the sheep came up to it, and block their escape.

So each morning the ewes would start up the track through the paddock, they walked straight towards the gate and then, just as they were about to pass the boulder, they would see Shep. The lead ewes would turn sharply to the right where Jock would be waiting to force them on to the gate. Over the years, this became such a routine that a path was worn from the farm, through the paddock to the upper field gate. The path went straight until it reached the rock, then it turned away sharply before straightening out back towards the gate.

As Shep grew older, he was used less and less to herd the flock. Indeed, several generations of ewes had followed the same route, so they all knew the right way to go. Jock too was aging and eventually he sold the farm, "lock, stock and barrel", and retired to the nearby village. There, he and old Shep would doze away the day at the fireside.

The new owner set out to make some improvements. He planned to upgrade the flock by bringing in fresh rams. He installed electric fences in the hope of keeping the coyotes out. Using a bulldozer and dynamite, he cleared the surface stones from the fields including the big one by the paddock gate; some of the stone was used to make a straight, dry track from the farm to the upper fields.

One day in May, in his first summer of occupancy, he found three dead lambs. So, like Jock before him, he decided to bring the flock down at night and sent his dog Moss to get them. The sheep came in willingly enough and quietly settled in for the night. The next morning, Moss started to drive them back up the new stone path. All went well until they got close to the paddock gate; then they all left the path and veered sharply to the right. Moss swung away to get them straight again and, sure enough, they turned easily back.

Years have gone by, and no trace remains of the boulder by the gate. Old Shep too has gone now but, in the collective memory of the flock, he still lies there waiting and to this day those sheep bend away from the path as they approach the gate. Moss and his master are still trying to figure out why.

Fall Foliage Championship Trial Qualifying Dogs and Handlers

All NEBCA dogs placing in the top ten at four qualifying trials are eligible to compete in the Fall Foliage Championship. Where a handler has three or more dogs qualified, he/she must choose which two of the qualified dogs to run in the Championship Trial.



Dan II

Through the spring, Dan continued to grow but he remained very immature in his behavior. Dan's idea of a good workout with the sheep consisted of running around the sheep as close and as fast as he could. As he became older and more selfconfident, my threatening efforts to widen him out no longer had any effect upon his attitude toward the sheep. This indicated to me that Dan was now mature enough to accept correction while working. Unfortunately he was so self-confident about his approach to the sheep that running at him, flapping a feedbag at him, yelling "get back" and any other threatening behavior I could think of also had no effect upon how he worked. If I ran at him to widen him out, he merely ran around me and continued on his tight way around the sheep. I began to think I had a really hard young dog on my hands and would be forever getting him trained. However, a little thought off the practice field reminded me of how sensitive Dan was to me when there were no sheep involved.

I decided it was time to stop fighting with Dan and to try a different approach. I worked on Dan's "down" command until he would stop readily and without fuss no matter where he was in relationship to the sheep. I did this by asking Dan to stop (in Dan's case the "down" is done standing up and merely means to stop) at the same time I stopped moving. When I stopped, the sheep tended to stop, and Dan, who has good directional balance, would hesitate because he was unsure of which way to madly run. He learned to stop readily and within a few days would stop pretty well when asked and would allow the sheep to drift away. The next time we worked sheep, Dan and I walked up to the sheep until they started to move away (about 50 feet away), and I then gave Dan a "Shhhh" command to head the sheep. When Dan started his regular tight fast run, I stopped him and walked up to stand between Dan and the sheep and told Dan to "get back out" in a quiet tone of voice. When Dan tried to run around me, I laid him down again and stepped between him and the sheep and told him to "get back out". Using my body, I blocked him and forced him back away from the sheep saying "get back out" and "good boy" when he moved in the desired direction (away from the sheep). When we were far enough away from the sheep, I again gave Dan the flank command to head the sheep. Of course, he started in tight again. I stopped him, and we repeated the get back out exercise. I had to do this several times until he was quite far back before he was able to get part way around the sheep without being too close. We repeated this a few times and then did some wearing. The next couple of days we repeated this "get back out" exercise. Dan underwent a conversion on about the fourth day when he quite suddenly understood that he wasn't supposed to be chasing the sheep but rather working a good distance off them.

All Border Collies have a certain amount of balance. When I start a young puppy wearing, I'm working with their directional balance. A couple of minutes holding sheep up to me and most young dogs will demonstrate that they understand which way to move to balance the sheep. Equally important is the distance balance, that is how close the dog must work to control the speed of the stock. I believe that most Border Collies possess this type of balance as well but it is sometimes a little more difficult to demonstrate to them how to use it. In most instances (like Dan), once they find that they can control sheep from a distance better than from up close, they will stay off the stock. Before a young dog like Dan can learn anything else he

most learn balance - distance and directional.

Once Dan understood that he was to stay back off the sheep. we could begin to work on lengthening his outrun. I did this by sending Dan a little further for his sheep each time he completed a successful outrun. If he started to cut in tight, I stopped him and said "get back out". He learned this very quickly. Within the space of two weeks, he went from being a hooligan to a very presentable young dog with a good 20 yard outrun. At this point I began to make more difficult outruns for Dan. I would send Dan into the woods to fetch the sheep. I would send Dan over the stream for the sheep and have him force them back across to me. I tried to think of the most challenging outruns and fetches I could for him. So far he has not once failed to bring the sheep. All of those months of wearing while I waited for him to grow up were good experience and taught him to bring sheep.

As soon as Dan understood about staying off the sheep on outruns, I began teaching him to drive. When Dan completed a fetch, I would encourage him to keep walking toward the sheep as they went past me. I would then turn so that Dan and I were on the same side of the sheep. Then I would begin walking beside Dan, encouraging him to drive the sheep away. Each day I would ask Dan to drive for a little longer and work a little further away from me.

Dan has now learned most of the major moves needed to be a good sheep dog. The next big part of his education is learning the commands for these moves. To teach Dan the flank commands, I first give the command. "Go bye" for example, and if he needs to go away from me to go bye I follow the "go bye" command with "get back" and he moves away from me. If the "go bye" direction is towards me I follow the "go bye" command with "here". I will continue to use these extra commands for a couple of months until Dan is confident in his directional commands.

During his early rampages around the flock, I thought Dan was going to be a hard-headed dog and a chore to train. To my surprise, he has proved to be a delight. He is very eager to do my bidding. He takes correction well. He never allows anything to get him down or interfere in his pleasure with work or life. He is a real delight. Lest it sound as if I am singing his praises too loudly, he has two faults I am working on now. He tends to be very left handed in his outruns. At home he runs left if I send him to the right. Also, when fetching sheep, he likes to walk beside them on the right hand side of the flock so that he can see where he is going. This makes for some very crooked fetches if I don't keep commanding him back to the left. Over the next several months we will be working to correct these faults.


