## AND HERE THEY COME - INTO THE HOME STRETCH

## Dan (Part IV)

It is November and Dan is now 16 months old. He has a fair outrun up to about 300 yards (that's as big as my field). He fetches the sheep quietly although not always as straight as I would like. He always brings all of the sheep, however, without hassling them. He drives nicely going away from me. Driving across in front of me (cross-drive) he is inclined to try to work his way to the outside of the sheep so he can bend them towards me and fetch them back. Most dogs will try to work the drive into a fetch if allowed to and Dan is no exception. When flanking, he flanks off the sheep squarely and keeps the same distance between himself and sheep as he goes around, not cutting in. Dan goes in the correct direction in response to the flank commands (vocal & whistle) about 90% of the time. If he makes an error he is inclined to persist in going the wrong way even if I repeat the correct command. He must be stopped and spoken to (DAN!!!) and then given the correct flank command to get him turned around. He stops very well but likes to keep taking little steps towards the sheep if they keep moving so he can stay in contact. Dan is now a useful, well started dog. To get him ready for eventual trial work, it is necessary to polish him up a bit.

Dan's style of working and my style of handling need to be melded together to make us a competitive team. When I give Dan a flank command, I want him to understand from that command how far around the sheep I need him to go and how fast I want him to travel going around them. It will take Dan and I a long time to reach this level of communication, if indeed we ever do. The rest of his training with me (which will last as long as we are together) will consist of our perfecting this communication. The first step in this polishing process is to increase Dan's self-confidence. Dan needs to be confident in his control of the sheep and in my judgement so that he can relax and flow easily with the many commands he must learn to obey. This confidence and relaxation must be built slowly. Gradually over the winter I will increase the number of commands I give Dan and the degree of perfection I am looking for in his work. Where, in the past, I was satisfied if Dan drove the sheep away from me, now I will begin to ask him to keep the sheep on a straight line as they go away. It takes a long time to get the kind of communication with a dog that I think Dan and I can achieve. Dan will learn very gradually to accept more and more direction as he works. This kind of heavily commanded work must be interspersed with days of undirected work so that Dan retains the ability to continued page 8

# The Fall Foliage Classic - October 9-10, 1993

This is about as far south as you can get and still enjoy the Fall Foliage AND the Fall Foliage Classic. In this author's sixyear experience, it is the first time that we have held this trial in the lower part of the Northeast. Now is the time for many of you, who would not or could not travel for six to ten hours, to get to see this classic close to home.

Nathan Mooney has agreed to host the trial, provide the sheep and be the judge; what a guy. Nathan's farm, less than 4 hours from New York City, is in Carlisle, Pennsylvania, just south of Harrisburg. He is just spitting distance for many of us who are practiced at traveling for six hours to Vermont or 10 hours to Maine.

Nathan's trial field is perfect. The outrun is over 350 yards, a dip in the middle, and then uphill. The drive is long and challenging, and the pressure is just enough to make you work for your points.

Spectators will stand just behind the handler and judge, so you have a perfect view of the entire course. It's a great spot for picture-taking, picnicking, and just plain relaxing. Come on out and join in on the cama-

raderie with the tops of our club's handlers.


How do you get there? Simple:

Nathan's farm is just off of US Highway Route 81, south of Harrisburg.

Take US Route 78 west to 81 south; or take Route 80 to 81 south; or take Route 81 south (or north if you are south of Carlisle). Please look at a highway map to figure out the best way to get to the intersection of Routes 78 and 81.

Travel south on Route 81, through Harrisburg, to exit 12. As I recall, it must be about 30 miles south of the intersection of 78 and 81.

The report did not include expense of \$696.37 for brochures. Also the Eye Clinic made a profit of \$84.00.

#### **Pamphlets**

Kathy Deschambeault brought reprinted pamphlets to be distributed to members. The Breeders Inserts are still awaiting the final OK to be printed.

Beverly Lambert motioned to reprint 1000 Breeders Directory Inserts and/or not to exceed \$100.00. Gene Sheninger seconded and the motion passed. Kathy will mail out the pamphlets to all those membership requests as soon as the inserts are ready. Thanks for all your patience. Gene and Kathy will continue working to develop a new pamphlet. The goal will be to produce a draft at the next Annual Meeting for a membership vote. Much discussion followed on the structure of the new pamphlet. There was varied input as to which direction the working Border Collie will take.

Library

Lin Reuther reported on the volume of requests. With interest on the rise regarding (1) Agility and (2) Search and Rescue, permission was granted to purchase a book on each of these subjects. There is a new video, Elvin Kopp Part III "Working Cattle". Lin will look into purchasing this one as well.

#### Fall Foliage Championship

Carol Campion announced the site for the 1993 Champion-ship will be the Farm of Nathan Mooney in Carlisle, PA. Nathan can provide over 100 sheep with a challenging course including a 330 yard outrun. He also agreed to judge the championship, to be held Columbus Day weekend. The only charge will be for the judging.

#### Newsletter

Gene Sheninger announced the next printing will be the week of August 1. Editors must have all info by July 20.

#### Hip Dysplasia Committee

Research continues on the genetics of breeding Border Collies. Members are encouraged to express concerns to any of the committee members.

#### **Nursery Trials Committee**

Eve Marschark questioned the Nursery Guidelines with regard to the sanctioning of trials with an approved judge. Much discussion followed on what the

qualifications of a judge are. Betty Levin suggested NEBCA sponsor a judging clinic. President Dick Williams appointed the Board of Directors to research the cost and report at the next meeting. The Trials Committee will work together on compiling and updating a list of NEBCA approved judges. Walt Jagger made a motion to eliminate 1.F. [For a Nursery Trial to be sanctioned requirements are . . . F. All judges used at these trials must be approved by the NEBCA Trials Committee.] from the Nursery Trials Guidelines. Carol Campion seconded. Motion passed.

#### **Trial Location Change**

Trial Manager John Roche announced the Irish-American Trial site has been changed. The new site will be at the Farm of Mike Canaday, Altamont, NY, July 30-August 1. The Trials Committee had previously approved 1 day of Nursery and two 1-day Open Trials. It would be acceptable to hold two 1-day Nursery Trials; however, only the first day will be sanctioned by NEBCA.

Eve motioned to adjourn and Barbara seconded. The meeting was adjourned by President Dick Williams.

These are excerpts from letters from adoptive homes for rescue border collies. As you can tell from the letters, these dogs can thrive with the right owners.

We have rescued and placed over 30 border collies which were in need of new homes. Typically, the rescue dogs are unneutered males between 8 months and 2 years old, which have received no training and have been chained out and ignored, or have been allowed to roam and wreak havoc. Some were bought as working dogs, were not trained, and worried livestock. It may surprise you that about half the dogs have bitten children, due to their herding instinct and lack of supervision, rather than aggressiveness. Many of those giving up their border collie bought it because it was smart, assuming smart means no training needed. In reality, it is the smartest dogs that need the most training, and the untrained B.C. soon gets into trouble.

Usually the rescue dogs come to our home for evaluation and some training prior to placement. All rescue dogs are neutered prior to placement, get shots and wormer, and are checked for heartworm. Potential adoptive homes are interviewed for suitability, and we try to match the personality

traits of the rescue dogs with those of the adoptive home. Since we are not independently wealthy, and do not receive funds from the club, an adoption fee of \$60 is usually charged to help defray the cost of veterinary expenses, food, gas, phone bills, etc.

If the breeder of the dog is known, we always call to see if the breeder will take the dog back. Unfortunately, it seems that the responsible breeders who are willing to do this are also the ones whose puppies are least likely to end up needing rescue, since their dogs are not sold to the first person with cash in hand. We have been told by some breeders that once the dog is sold, it is the owner's problem. This attitude hurts not only the individual dog, but the breed as a whole.

If you or someone you know would like to adopt a rescue dog, please call us at (207)583-2353. Breeders, feel free to refer good homes to us if a caller expresses interest in an older dog. Some of you have already done this, and we really appreciate it!

think for himself.

The first step in this process is the "hurry-up, come in tight" whistle. My right flank command is a long whistle moving from one note to another. My "hurry-up" right flank whistle is the same only very short and sharp repeated several times. To teach Dan this whistle I have him drive the sheep away about 50 feet. Then I flank him to the right around behind the sheep. This causes my sheep to come running toward me. While Dan is still flanking around to the right I give him the "hurry-up" whistle and I run around the sheep to the right, clapping my hands very excitedly. This results in something between a right flank and a flying grip down the right side of the flock. Once Dan has learned that this "hurry-up" excited whistle means to run tight around the sheep perfecting it only requires a little practice.

The other whistle I teach at this stage is the little flank whistle. This is the command to move just a little bit, sometimes inches in either direction. To teach this I start Dan driving the sheep, I walk along beside and a little behind him. I give him a soft short flank followed almost immediately by a walk up command. This teaches not only the short flank, but also to walk up from the flank command. I want to eliminate the stop command from Dan's work as much as possible. I prefer to give one command followed by another without stopping the dog before giving the next command.

I work on only one of these variations at each practice session. If we practice the hurry-up right flank, we won't practice the hurry-up left flank in the same session. It is also necessary to keep going back to the regular go around the sheep flanks so we can remain clear about the basic flank commands and continue to perfect Dan's obedience to them.

derstand these commands, I began teaching him to shed. I use the entire flock to teach this command. I like to use voice commands with my dogs when shedding. It is a clue to the dog that we are shedding, and it makes it easier for me to call the dog into the sheep. To teach the shed, I position the sheep between me and Dan. My flock of 30 sheep shed very easily, so I don't need to back them up to a fence in order to do an easy shed (a fence which they would just go through anyway as soon as Dan pressed them). I walk into the middle of the flock of sheep and I call Dan to me. I keep calling Dan and backing up into the sheep until he comes. When he gets to me I praise him and we walk away from the sheep a 100 yards or so and I send him on a gather. After a couple of sessions Dan got so he came into the sheep very readily. At this point I could turn toward one group of the sheep and walk him toward them. This is where the short quiet flank commands came into play. As the sheep tried to duck around Dan and rejoin the other half of the flock, I could use the new short flank whistles to help him control the sheep. Dan and I then drive the shed sheep away from the others and we quit for the day with the two groups of sheep separated. I want Dan to understand that once separated the sheep must stay apart. At this stage, if one or two of the shed sheep get away from Dan in the early part of the shed, I just ignore them. Once the groups are about 50 feet apart, we both work hard to keep control of our group and prevent them from rejoining. In the Spring when he is confident about shedding and working challenging sheep, we will begin to decrease the number of shed sheep until we are down to the single. Once Dan is a confident shedder, teaching the single shouldn't be difficult. Attempting the single too soon could easily result in the single sheep getting away from Dan and shaking his confidence.
