

1994 Annual Meeting

The NEBCA Annual Meeting was held at the farm of Mike and Pat Canaday of Altamont, NY on February 5, 1994. The meeting had to be delayed by a week due to snowy weather. It was well worth the wait as temperatures soared into the 30's. A wonderful pot-luck buffet luncheon was enjoyed by all who attended. After the meeting the members had the opportunity to go dog-sledding. It was an exciting and

memorable time for all, dogs included! A sincere Thank You is extended to Mike and Pat for all their time and efforts in making us all feel so welcome and comfortable. Much appreciation to the members who attended making this a successful and productive meeting.

The meeting was called to order by Dick Williams at 10:45 AM.

Secretary's Report

The secretaries report was read by Kathy Deschambeault. Kathy reported that NEBCA growth continues with 104 new memberships processed this year totalling 426 NEBCA members. Trials and

clinics still topped the list of interests of members with other interests such as obedience, agility, cattle work, search and rescue, dogsledding and flyball listed. Several non-trialing members offered their assistance at trials. They were encouraged to contact the trial managers as all help is greatly appreciated. The report was accepted as read.

Treasurer's Report

Treasurer Barbara Armata presented the treasurer's report. As of 2/1/94, the balance in the checking account was \$6,750.62. She received \$1,617.85 from calendar sales at the meeting making a grand total of \$8,368.47. Calendar profits

up to this time are \$1,214.86. Memberships continue to flow in. Barbara is checking into registering with the IRS to become incorporated as a non-profit organization. Gwen Cassel and Beverly Lambert offered to help Barbara with this research. The report was accepted as read.

Treasury Audit

Pat Canaday reported on the treasury audit that she and Walt Jagger compiled.

With a few minor discrepancies, recommendations were made and accepted. The audit went well and the books are in order.

Trials Committee

Becky Peterson, chairperson, reported on the growth of the trial scene. In 1985 there were 12 trials compared to the 56 trials held in 1993. She requested that all trial managers get their trial information to the committee for approval and sanctioning by NEBCA. Becky also presented two recommendations from the trials committee. They are as follows:

1) Breaking of ties at the fall foliage championship. In the event that there are ties in the final top-ten standings, ties for

first/second place and second/third place will be broken by a run-off with the run-off course determined by the judge. Ties further down will be broken by the combination of outwork scores of the first 2 runs. If the tie is still not broken, a progression will be made to the drive, the shed, the pen and finally the third run.

2) Amendment to #7 of the Guidelines for Qualifying Trials: Addition as fol-

lows: Points trials will be accepted. The judging method, i.e. judged trial or points trial, must be approved and advertised at the beginning of the season (April). The trial must then be judged and scored and run as advertised or sanctioning as a qualifying trial will be removed. As in a judged trial, grips will not be allowed nor will retries be allowed at any fetch gate or drive panel. Eve Marschark made the motion to accept these recommendations. Larry Campion seconded and the recommendations passed.

Becky submitted her resignation as Trials Committee Chairperson. It was regretfully accepted. Becky has done a

tremendous job resolving the problems the committee has encountered in the past. Becky will, however, remain on the Trials Committee. Steve Wetmore presented Becky with a Fine Arts Border Collie figurine as a thank you gift from the association. Dick Williams welcomes Eve Marschark as the new Trials Committee Chairperson.

With 56 trials per year, there comes a lot of record keeping with many scores to tabulate and keep current as to who runs in the Fall Foliage Championship and who the NEBCA High Points Dogs are.

NEBCA wishes to formally acknowledge and thank Eleanor Jagger for the time and effort she puts into keeping these records. She was presented with a lovely Border Collie commemorative plate and much appreciation.

Nursery Trials Committee

Chairperson, Eve Marschark reported on the successful year the Nursery Trials program has had. She thanked Carol Campion for keeping track of points for 195 nursery dogs. For 1994, the Committee will have a change of members. Eve Marschark has stepped down as chair to take over the responsibilities of Trials Committee chair. She is replaced by Beverly Lambert. Michael Dathe has resigned and will be replaced by Warren Mick.

Denise Leonard and Carol Campion remain. The committee presented a total of 27 awards to those dogs that had mastered classes this past season.

Calendar Report

Steve Wetmore reported that there were 150 remaining calendars for 1994 from the 865 originally ordered. He recommended that the inside front cover contain a history of NEBCA and information on the club. With the calendar showing a profit of \$1214.00, he recommends publishing it again next year. Steve, however, would like to relinquish his position as contact person for the calendars. Any person interested in being the contact and distributor, please call Steve. Denise Leonard and Kristen Whittle will remain the Calendar Make-Up Committee for the 1995 calendar, after which they will resign.

As of the present, the remaining 1994 calendars will be sold at \$5.00 each. Contact Steve Wetmore for them. A motion was made by Beverly Lambert to increase the cost of the calendars to \$8.00 each, which will include postage. This will start with the 1995 calendars. It was decided that anyone selling them at trials may sell them for \$5.00 each. Seconded by Barbara Armata and passed. Gene Sheninger made the motion to reprint 865 calendars for 1995. The motion passed.

Newsletter Report

Gene Sheninger, Co-editor, announced that the new By-Laws and Event Guidelines Rule Book has finally arrived. It is out in the mail to anyone who ordered one. The Rulebook is available for \$2.00 each and is a worthwhile guide.

The cost of producing the newsletter is \$7.00 to \$7.50 per member. The following recommendations were made:



1) Any new member who joins NEBCA after October 1, will receive their membership through December of the following year. (i.e. October 1, 1994 through December 31, 1995.

2) Continue the newsletter with 4 quarterly issues and up to four supplemental issues per year, not to exceed the budget of \$3500.00. These recommendations unanimously passed. Gene and Lynne thanked everyone for the assistance they received while producing the newsletter the last four years.

Walt Jagger presented them with a beautiful Fine Arts Border Collie puppy figurine as a token of NEBCA's appreciation for their work.

Board of Directors Report

Chairperson, Mike Canaday, thanked everyone for coming to the meeting. Though he was not there, a special thanks was extended to Bernie Stahl for the chairs and tables and his participation in the preparation for the meeting. The floor was given to Cheryl Jagger Williams. She presented these recommendations by the Board of Directors:

1) The board would like to clarify that NEBCA was originally formed to promote the Working Stock Dog and feels that sentiment should be preserved. This was approved by 34 unanimous votes.

2) The Breeders Directory will not change its name at this time but will significantly expand it's disclaimer statement. Additionally, starting in 1995, the Breeders Directory listing fee will be increased from \$10.00 to \$20.00. This income will be earmarked for year-end awards for Open and Nursery classes. After a discussion, Gene Sheninger made the motion to accept the recommendation. Beverly Lambert seconded. The vote was

taken. It was approved by 33 and opposed by 1. The recommendation passed.

NEBCA Librarian

Lin Reuther, librarian. reported on the activity the lending library has seen. Videos were borrowed 101 times! Books were only lent 23 times. Lin recommends that we continue with the pricing structure of \$3.00 per video and books for free. NEBCA purchased 4 videos and and had generous donations of 2 videos and 3 books. Lin received approval to purchase the 1991 and 1992 International Supreme Trials Videos that we do not have.

Responsible Breeding Committee

Michael Dathe, committee chairperson, reported on the committee's findings of the last year of research. The Breeders and Buyers Guidelines that the committee is working on will be voted on separately upon completion. There was a great deal of open discussion over these issues. The organization request that any opinions be sent in writing. Send these to Michael Dathe or Steve Wetmore. The Board of Directors will appoint 3 members to continue to work with Michael on this committee. A formal policy will then be compiled by the Board of Directors. Also, an OFA booklet will be available through the NEBCA library.

General Information/Announcements

- An eye clinic will be held this year at Jagger's Hop Bottom Trial in June. Details will be announced closer to the event.
- Discussion on the date change of the annual meeting will take place at the Cummington Sheep Dog Trial.
- The Trials Committee is responsible in full for NEBCA's Fall Foliage Championship Trial.

The North American Border Collie Rescue Network

A nationwide support system

The Border Collie is fast becoming a popular breed in North America and more and more Border Collies are in need of rescue each year. Numbers of people have been involved as individuals for several years in Border Collie Rescue. Recently, there was a "worst case" situation where people in Texas were called to rescue over a hundred sheepdogs of all ages. When a large number of dogs are rescued, an areas resources can be strained or exhausted, and a rescue person must seek farther afield to find appropriate homes. Furthermore, many doing Border Collie rescue at the moment are suffering from "burn-out" because of a paucity of resources for them to fall back on. There is a need for a national Border Collie rescue effort. This need was expressed poignantly by one rescue person. "It's lonely out there," she said.

Operating free of political binds

Unlike other breeds, the Border Collie does not have one national breed organization or registry. The AKC does not yet recognize the breed, and if and when it does, this will not necessarily meet the needs of many owners and breeders of working Border Collies who will not register their dogs with the AKC. The breed has a history of splintering, and there are at present three national breed registries and a number of national breed and working clubs for the Border Collie, none of which show any sign of willingness to cooperate in a single breed society and registry. Their philosophies and functions differ, and are often at odds with one another. The suggestion that a rescue organization should be associated with a national breed society is admirable, but probably unworkable for us at the present moment.

What would probably work better for us is a single, separate, national rescue organization, ideally supported by all the registries and breed societies, but affiliated with no one of them. An independently operating national breed rescue effort could serve the needs of the Border Collie rescue community at large, and ultimately the needs of the breed.

And so, to begin...

The North American Border Collie Rescue Network (NABCRN) has been launched in the simplest of all ways: as a listing of those of us who are involved with Border Collie Rescue in North America (United States and Canada). Later a newsletter may be started, but for now the **Shepherd's Dogge magazine will publish the list**. The list will be maintained on our computer and can be obtained by sending a long, self addressed, stamped envelope to the address listed below. Those seeking rescue people in particular areas can phone and individuals can be looked up for you.

Only rescue people who ask to be listed will be. Please indicate the geographic area you cover, whether you house your rescues or do only referrals, and any other special services you perform, (i.e. evaluations, training, veterinary clearance, neutering, follow-ups, etc.) Some people doing Border Collie rescue may not receive this publication, so please, if you know others doing rescue, please let them know of this network.

For now, there are no "dues" being asked. However, donations would be appreciated to help defray the costs and make a newsletter and other printed material possible. Input and expertise from those of you already doing Border Collie rescue will be invaluable. We need to know who you are, what you have been doing and how you have been doing it, what else you want in a support system, and what more you feel a national rescue organization should be. I am hoping you will come forward as this progresses, and that some of you will be willing to take over the organizing of things, leaving me to the communications, which is what I do best. If you don't "do" rescue, but are willing to foster rescues or help in any other way, for information or to be involved, or to be listed as a Border Collie rescue person, please contact:


