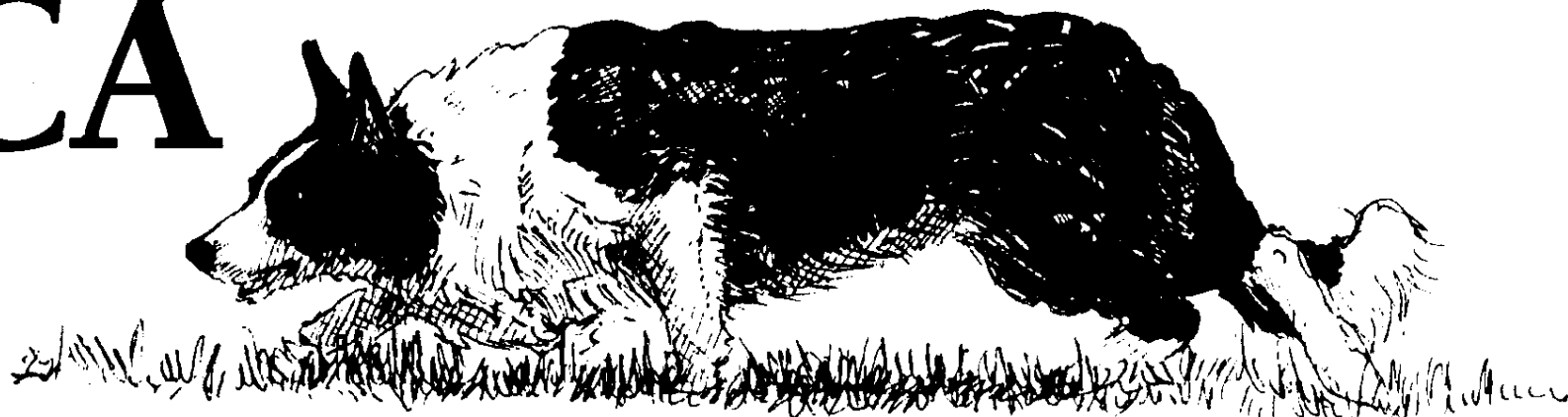

Consider This.....

Everyone does, can, and must form an opinion on life's experiences. Sitting back and keeping one's opinion to one's self is of no gain what-so-ever. Therefore, by putting my money where my mouth is, I have compiled my observations of dog-trialling over the past four seasons, along with some suggestions for "improvements" to the sport on both sides of the border.

A. It would be a fair assumption that a sanctioned trial would have all the necessary criteria that the clubs would agree upon. Once deciding to participate in a given trial, the contestants would therefore, before leaving home, know what

number of dogs are necessary for sanctioning, ribbons to what place and lastly, (a most difficult area) to what place does it pay? This is probably the second most, however quiet, complaint that one may hear. I am more than aware of the costs that arise in hosting a trial; judge, ribbons, fencing, wire and gas, which rarely gets full reimbursement, are but a few of the basics. Again, we all know there are costs getting to and from a trial, and believe me, an 8th place pittance is far better than a 4th place "Thank you for coming". The solution could be that guidelines could be set up which recommend what % is paid to what dog depending on the number of dogs.

Example:	20 dogs @ \$25.00 each=\$500.00.
Expenses:	\$200.00
Payout:	\$300.00
Therefore	1st gets 20% of \$300.00=\$60.00
	2nd gets 20% of \$240.00=\$48.00
	and so on.....

*Please note that Nursery Class entry monies have not been included in the above example. The money from Nursery Classes should be included when one is calculating prize money, but how often that is abused.

Now, the question is, "Just where would the money come from in the case of a trial being financially strapped?" I believe that the ABCA does something as far as registered dogs per state and province (I may be wrong) but the point I am trying to make is that the clubs have a duty to the breed and if it is the case of digging into the coffers of NEBCA, (OBCC does this already) then do so. If membership fees need to be raised, then do so. The non-competing members must realize that the SDT's are the public's window to the breed and the casual breeder would be NOWHERE without them.

B. Judge: definition: One who gives an authoritative opinion. Not to be confused with "Judgement Day" which has been the case in the past. We, the competitors, must never forget the word "opinion", we do pay dearly for one; a fair one! I am not saying that corruption

is running rampant in the Sheep Dog Trialling World, but I think it is the club's responsibility to seat an unbiased, qualified person in the judges chair. What do you do in the case you think you have been shamed? Well, rarely does this happen, but it does. Here I will express some of my options:

- 1) Do not return
- 2) Return and document the complaint in writing to the club.
- 3) Return, run your dog and say nothing.

I would refrain from dropping out of a club. This is an extreme measure and only adds difficulty on returning. Unless a complaint is written down, it can lose some emphasis. Also, what may appear as a monumental problem can turn into a non-issue by the time it gets to print.

C. Lastly, I would like to bring up the subject of an ethic's or handler's creed. This pertains to one's public attitudes to their dogs, fellow handlers and the public in general. Our sport is now in the public eye more than ever. To be politically correct today is of the utmost importance. It would be a shame not to be allowed to continue this sport for lack of wisdom.

Try A Clinic, Why Don't You?

Have you ever thought about attending a clinic? This is the season! This spring and summer, there will be many high-quality clinics offered, each focusing on a different aspect of Border Collie training and/or handling. The instructors for these clinics are all experienced experts that have developed a style and format that make your time and investment worthwhile.

Cheryl Jagger-Williams, of Hop Bottom, Pennsylvania, has been training, trialling and handling Border Collies for many years. She trains professionally and her clinics fill quickly. She has a reputation for making beginners feel comfortable by her handling of their dogs and her ability to explain things to them. She herself is an expert handler, finishing in the top 10 at this past years finals. She is able to help any advanced handler with his/her trialling/handling skills. She will be in the Northeast at a number of locations throughout the summer. Try to catch her at one of these!

A newcomer to the U.S. is Alasdair Gilchrest. Hailing from Scotland, he is coming in May to judge Roger Deschambeault's, Dave Young's and the Cummington Sheep Dog Trials. He will be leading clinics that are planned following both Roger's and Dave's trials. These clinics will be geared to address the needs of the attendees. Overseas handlers and judges offer new insights to our handling and training and even if you are successfully trialling, something can be learned from each of these. Give this one a try!

Coming to Fitzwilliam, New Hampshire in late July is Alasdair Macrae, the 1994 winner of the International Supreme. Alasdair has done clinics in the South and is very popular. He focuses on the more advanced dogs, handling his specialty. He is hoping to help us with Double Lifts, International Shedding and smooth driving. Open handlers may will particularly enjoy this one. (He is also an expert Penny whistler and so expect to hear some music, too.) **Continued on page 2**

Support or Promote

The by-laws of the Northeast Border Collie Association state that their objective is "to promote the Working Border Collie". I find the word "promote" troublesome. I think NEBCA should place its emphasis on "supporting" the Working Border Collie rather than "promotion".

There is a big difference between "promoting" and "supporting". The image of promoting too often lies with words such as advertising, sales and money.

The word support" is about guarding the genetic base of the best Working Collies, confronting abusive treatment, checking overbreeding and puppy mills, adhering to the breeding guidelines while pursuing bloodlines free from genetic

defects. If NEBCA is not first and foremost about these concepts, it does not act in the best interest of the Working Border Collie.

The NEBCA meetings are consumed by talk of advertising, trials, money, sales, subscriptions, points accumulations, tie breakers and calendars. The health and welfare of our dogs, the linchpins that hold the organization together, are scarcely mentioned. Changing a word in the by-laws will not alter that, but it will put us on record as recognizing the difference.

I ask the general membership to ponder the difference between the two words and to deliberate an eventual amending of the by-laws.

Get Out to a Trial

Coming in May are a number of trials to get out and see. There are a variety of locations offering a good mix of work conditions for the dogs as well as lovely places to visit for a day.

In early May is a favorite, Cooperlane Nursery Trial. Held at the beautiful hilltop farm owned by Edgar Gould, it is the traditional season starter for many nursery dogs.

In mid-May is a farm trial at Roger Deschambeault's in Center Conway, New Hampshire. His farm is situated in a beautiful location with North Conway, New Hampshire a stone's throw away. Come watch the trial and then do a little shopping.

Then its up to Lennoxville, Quebec to Dave Young's trial. This trial is put on with the help of the University. There are food and other displays available as well as a challenging sheep trial.

Later in May is the Massachusetts Sheep & Wool Festival Sheep Dog Trial in Cummington, Mass. In addition to the trial, there is lots to see and learn. There are sheep shows, wool sales and much more. This trial is very popular and attracts at least 40 to 50 dogs a day. The young dogs run on Saturday and the open dogs on Sunday.

All of these offer a day of fun and relaxation. If you've never seen a trial, get out and see one!

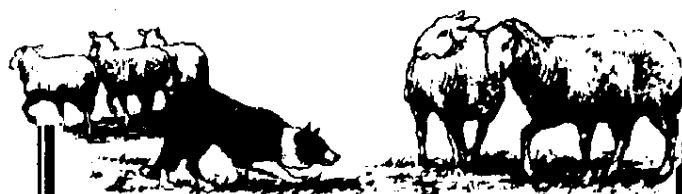
