The Connecticut Sheep Breeders held their annual Field Day and Sheep Dog Trial on Sat. April 26, 1997 at the Tolland Agricultural Center in Vernon, CT.

It was a fine day for a trial, lots of sunshine and temperatures in the 60's. The outrun of 175 yards presented little problem for most of the dogs. Mike Canaday's Dorset sheep were used and worked well if the dogs did not push too hard. While the pen was almost automatic, the shedding ring did give problems and very few dogs were able to get full points.

The trial was ably judged by Steve Wetmore of Strafford, VT, assisted by Joanne Krause as clerk. Thanks to Warren Mick and Betty Levin for setting out sheep, and to anyone else who lent a hand. Also thanks to all the handlers who make all trials a success. The score was of a possible 100 points. A total of 31 dogs ran.

Editor's Note

NEBCA, with some financial help from the American Border Collie Association, had a really special day on Saturday, May 24th, at the Cummington trial. It was a day for promoting border collie health. Fifty-seven dogs were tested by Dr. Donovan at an eye clinic, for only \$15 a dog. (report below) And in the evening, after the day's trialing and a pot-luck dinner, Dr. Lau gave an excellent talk on hip dysplasia and the PennHIP system for measuring hip joint laxity.

Dr. Lau's talk was the most cogent explanation of the PennHIP system of detecting dysplasia I have ever heard. He explained the way the PennHIP measurements are done and offered some very convincing evidence for the value of selective breeding, giving data showing how quickly it can reduce the incidence in a line. He also suggested that real progress can only be made if breed clubs start their own registry on dysplasia and share information so that the breed can be improved. ABCA is going in this direction – a dog's OFA rating can be added to the registration (along with the results of eye tests), although it is not required. NEBCA might be able to be in the forefront of this – perhaps we should consider how we can help. Education, through means such as this talk, is a big step in the right direction.

I took notes on the information Dr. Lau presented and will summarize it in a future newsletter after I have had a chance to talk to him again. That way, even if you couldn't be there, you can benefit from this exceptional lecture.

Eye Clinic held at Cummington Trial

Dr. Donovan, veterinary ophthalmologist of Burlington MA, conducted an eye clinic at the Cummington trial. NEBCA received \$75 from ABCA to help sponsor the clinic, and 57 dogs were tested.

There were no cases of PRA or CEA, but Dr. Donovan found some instances of cataracts. It isn't possible to tell if they are slow or fast growing cataracts from one exam, and the dogs will need to be watched for progression of the problem. He also found a few dogs with scarring, which can be due to any of several causes, parasites or a bacterial infection as well as trauma to the eye. There were also a few cases of persistent pupillary membrane. (According to the Merck, these are "remnants of a congenital vascular network that filled the pupillary region. Persistence of pigmented strands across the pupil from one area of the iris to another, or to the lens or cornea, is not uncommon. In the Basenji the condition is inherited.")

Dee Woessner wrote the grant to ABCA, and helped organize the eye clinic, and George Northrup and Kate Collins worked almost the entire day signing people in, putting drops in dogs' eyes, and making everything run smoothly, with help from Rich Weltzin.

Why visit the vet?

At least once yearly your dog should visit your veterinarian for his vaccinations and heartworm test. The essential vaccinations are rabies and the distemper combo (distemper, hepatitis, parvovirus, parainfluenza and leptospirosis). Depending upon the state, rabies may be given every one, two or three years. Where appropriate you also may want your dog to have the Lyme vaccine and/or kennel cough. All dogs, but especially dogs in contact with live-

stock, should be dewormed or have a fecal exam every year. Your dog should also be on daily or monthly heartworm preventative medicine during the mosquito season and should be checked for heartworm disease yearly.

If you have a sick animal it is obvious why he needs to see the vet; however even if your dog stays healthy your vet can give you advice on nutrition, breeding, behavior issues and potential health problems or any other concerns you may have

A new puppy should be examined by your vet as soon as he arrives. I vaccinate pups for distemper, hepatitis, parvo and parainfluenza every 3-4 weeks from 7 to 16 weeks. Rabies can be given at 3-4 months and I start puppies on heartworm preventative at 8 weeks. Every pup should also have a fecal sample checked or be de-wormed when you first get him.

Vaccinations and heartworm and fecal checks are only part of why you should take your dog to see your veterinarian. If you have a sick animal it is obvious why he needs to see the vet; however even if your dog stays healthy your vet can give you advice on nutrition, breeding, behavior issues and potential health problems or any other concerns you may have about your dog. If you go in prepared with a list of questions you'll get the most out of your visit .

When a dog comes into me I make an overall assessment of the dog's condition when he walks in the door- is he fat, thin, bursting with energy, does he have a nice shiny coat or obvious problems like lameness. I also greet the dog and based on his reaction I learn if the dog is fearful and submissive or self-confident or aggressive.

I ask right away if the animal is having any problems. A lot of clients don't bring up a problem when I first ask but as the exam continues they remember their concerns. Others come in with a laundry list of questions. If a problem exists I obtain a history and make a list of possible diagnoses. I try to avoid setting my mind on any one diagnosis until I've examined the animal. Often the diagnosis is strongly suggested by the owner's description of the problem. Sometimes I can make a diagnosis based on the physical exam. Some problems require further diagnostics such as bloodwork, urinalysis, radiographs, ultrasound or surgery. If I can't solve the problem I refer the client to a specialist (eg, orthopedic surgeon, ophthalmologist or cardiologist).

My physical examination of the animal is always done in the same way. I start at the head and exam-

ine each organ system. I examine the system with the suspected problem last. My examination covers the eyes, ears, nose and throat; lymph nodes; cardiovascular and respiratory systems; gastrointestinal and urogeni-

tal systems; musculoskeletal and nervous systems and the skin. Briefly I am looking for the following problems:

Ears - odor, signs of infection such as discharge, redness or swelling; foreign bodies or tumors.

Oral - dental tartar, gum infection, missing or loose teeth, odor, foreign bodies, tumors.

Eyes - cataracts, discharge, etc.

Lymph nodes - enlargement can indicate infection or tumor.

Cardiovascular and respiratory - irregular heart rate or rhythm, heart murmur, abnormal lung sounds. I check pulse quality by palpating the femoral artery and capillary refill time by checking gums in mouth.

Integument - tumors, infection or sores, inflammation, self-trauma, hair loss, coat quality-FLEAS!

Gastrointestinal and urogenital tract - I first check external sex organs of males and females for tumors infection etc. I always do a rectal to check prostate size on intact male dogs over 4 years of age. I always palpate internal abdominal organs- does the bowel feel normal, is the animal painful on palpation, are organs such as kidneys, spleen and liver normal size and

shape. I feel for masses or foreign bodies, bladder stones. Your vet can often detect pregnancy if the bitch is palpated at 21-28 days gestation.

Musculoskeletal system/nervous system - palpate joints, spine, muscles to assess for flexibility, pain, fractures, etc. Is the dog fat, thin, fit, etc? Are there neurologic deficits?

As I go over these organ systems I explain my findings and encourage the owner to think of relevant problems such as vomiting, diarrhea, increased water consumption or changes in urinary patterns. Is there exercise intolerance, lameness, coughing, sneezing? Sometimes I'll detect a problem of which the owner is unaware. Some owners come in as soon a problem appears; other wait until a problem has gotten so bad they can't ignore it any more (and sometimes too late for us to be of help). Some people are frustratingly unaware or vague and I have to gain all my information from the animal itself. Often an owner gives an accurate description of the problem or a correct diagnosis (Doc, my cat has diabetes). Through experience I have learned -Never ignore what the client tells me about their animal- the diagnosis is often found in the history.

I always ask the following questions when an animal comes in with problem:

What is the complaint?

When was the dog last normal? Was there a triggering event? Has he had this problem before and if so what happened?

What is the problem? Coughing, sneezing, diarrhea, lameness, scratching, change in urination patterns (increase decrease in amount and or frequency), drinking more water, anorexia, lethargy?

Is the problem improving or worsening?

Are your treating the problem? With what? How's it working?

From these questions and my exam I'll determine a list of possible diagnoses. This list may lead to no treatment with the expectation the problem will resolve on its own, initial treatment, or further diagnostics. Often the optimal diagnostic or treatment plan is not possible because of financial constraints so I have to work within the owner's budget. If our initial treatment fails it is important to stay in touch with the owner so we can change tactics until we find the solution. Good communication between client and veterinarian is essential with an ongoing or intractable problem. Your veterinarian may not be able to diagnose or solve your dog's problem right off the bat; it's not realistic to expect that. It is reasonable to expect him to work with you to find a solution or to refer you to someone who can help if he can't. I was taught that if you can't solve a problem within three visits you should offer referral. O

Minutes of the Cummington meeting, May 24, 1997

The meeting was called to order by President Dave Young at 8:20 PM in the dining hall, following the trial and a pot luck dinner.

Dave Young gave the president's report. New members were appointed to the nursery trials committee, through consensus of the executive committee, mixing novice handlers with some experience with relatively young open handlers. Some items were tabled due to the time, and the talk on PennHIP to follow the meeting.

Betty Levin and Alex McKinven were given special recognition for their contributions to the club by being awarded life memberships. This was proposed by Dave Young and approved by unanimous voice vote.

Dave Young announced that it was customary for the incoming executive to do something for the outgoing members. A gift was presented to Carol Campion, who was the previous newsletter editor. A gift was to be sent to Gene Sheninger, the former president.


