Three Women and a Dog

Totsi started off her life with some serious rough spots, and as a result was pretty skittish and shy in the best of circumstances. It took a lot of confidence building and reassurance on the part of her first rescue person, Cheryl Jagger Williams, followed by New Hampshire resident Janet Larson, to get her to a point where life could be enjoyable again. After two years, Totsi's shyness and early lack of socialization with other dogs caused Janet to decide to place her in a one-dog home with lots of human loving and attention. Nancy Phillips, a Border Collie Rescue person in Vermont, found such a home with Vermonter Nan Hornbeck, a woman whose work would allow Totsi to be with her all the time, plus a little farm work each day. What a life Totsi would have!

When the time came, Janet left her with Nan, who took her 'new' Totsi on leash for a walk in her sheep pasture. Nan saw something, bent to pick it up, and inadvertently dropped the leash. When she stood up quickly, Totsi spooked and ran, hit an electric fence, and bolted away.

That was the beginning of a memorable and difficult search effort. Janet returned to Vermont the next day with Magnum, her tracking dog, to help Nancy and Nan search for Totsi. The women spent hours walking around the hilly and wooded country in hopes of spotting some sign of her. To complicate an already bad situation, it was the record year of rain, snow, and storms that caused massive flooding in Vermont. Roads and fields were under water, and there was serious danger of a loose dog getting washed away. Janet also brought other dogs with her, to bark and leave scent marks in hopes of attracting the elusive (but nearby) Totsi. Nancy put up posters at all the intersections in the area, placed ads in papers over a 40-mile radius, and went door-to-door with flyers. There were numerous phone calls with a number of sightings, but no Totsi.

After a week, Vermont had one of the worst thunderstorms in its history that lasted over an hour. Wild thunderbolts and torrential rain covered the state. Janet came back to Vermont at

A light has gone out: Topsie Conboy 1909-2000

For almost forty years, Topsie Conboy has been a fixture on the sidelines at sheepdog trials. My good fortune is that I was there during part of that time. I am one of many who are richer because Topsie touched their lives.

From the trademark bandana tied about her head, to a man's plaid flannel shirt, tennis shoes and cotton in her ears to protect against the wind, Topsie was unique.

She was there when I won my first trial in August of 1979. It was Pope Robertson's Texas National Open. Normally, tie scores are settled by the best score on outwork. However, at this trial Pope had announced up front that all ties in the top ten places would be settled by a tiebreaker run. Topsie's husband George and I tied for first place. The most vocal supporter I had during the tiebreaking run was Topsie. She ran on to the course and gave me a big kiss when it ended, right there in front of George and God and everybody.

She was a believer in physical fitness before it became fashionable to be fit. In the mid-seventies, she was pushing other overnight campers at the trial sites to join her for early morning walks. The faces changed from trial to trial but the one constant was Topsie. She was the cheerleader for what I ultimately named the "Topsie Turvy Jogging Club."

When I learned of the passing of Topsie, my first reaction was disbelief. A world without Topsie was unthinkable.

Life expectancy for females in the US is about eighty years. Topsie was ninety-one. It may be that God chose to do us a favor and allowed Topsie to grace this world for eleven bonus years. It also may be that it took God eleven years to muster the courage to tell Topsie anything.

One never had to wonder where one stood with Topsie. Act like a jerk around her and she would, by God, tell you what a sorry one you were. Not in a meanspirited way, but in a matter of fact way that made you wonder how you could ever have committed such a faux pas.

I have been calling the Conboy home for the last twenty-three years. I never identify myself, I just ask, "What are you doing?" Without fail Topsie's answer was, "I was just sitting here waiting for you to call." She recognized my voice even though sometimes it had been a year or more since she had heard from me. That is, until last year when she broke her hip. As soon as I heard, I called the hospital. I was surprised when she answered the phone herself. I was devastated when she didn't recognize me, even after I told her my name. I couldn't believe this vital mind had deteriorated so much in acuity since I had last spoken with her. I called again the next day and again

Topsie answered the phone. This time I heard the familiar, "I was just waiting for you to call." When I expressed the concern I had felt the day before I got Topsieized. "What the hell did you expect, you stupid SOB? You called before I came out from under the anesthetic."


I met Topsie and George in 1977 when I was thirty-seven years old. George was 67 and Topsie was 68 at the time but I never considered them as "older." The fact that they were both older than my father didn't keep me from considering them contemporaries. Even though they were retired, they were young and vital and projected a sense of life almost unheard of in this modern world.

I don't think Martha Stewart spent a great deal of her time looking over her shoulder because of Topsie. Still, all of us at trial sites benefited from the time she spent in the kitchen of their old Coachman "fifth wheeler." She would throw together a big pot of stew and invite all the regular crew over for supper. At one trial in the seventies, she had about five gallons of beef stew cooking when the course director decided he wanted all the motorhomes and travel trailers moved to the other side of the course. George moved the trailer without knowing the stew was on the stove. Naturally the five gallons of stew moved from the stove to the floor. Everyone was running around trying to figure out how to clean up such a mess. Didn't bother Topsie at all. She borrowed dogs from everyone within earshot, threw them all in the trailer and ten minutes later ran a damp mop over what was essentially a clean floor.

Topsie never lived more than a mile from the house where she was born. If you think that made her provincial you would be wrong. She was a cosmopolitan, a citizen of the world; just as much at home with staid New Englanders in Maine, us rednecks in the South, or prim and proper British Judges.

Topsie was a myriad of things. Animated character, loving wife and mother, and loyal friend were only a few traits of many. Her most enduring legacy will be the contagious happiness that radiated from her soul. We all have souls, but some of them shine more than others. Topsie's was the brightest.

Editor's note: While Topsie Conboy was not from the NEBCA area, she was well-known here. This tribute to her life by one of her biggest fans is testimony to her impact.

that time, but there had been no Totsi sightings. All the women were pretty discouraged. Then, Nancy started getting telephone calls from people in the neighboring area of her home. Totsi must have been driven over the mountain in fear. The numerous phone calls helped to pin Totsi's movements to within in a mile of Nancy's house, and they were able to track her in circles. Janet and Nan camped out in their trucks, while Nancy stayed home to answer the phone.

Janet returned to Vermont for the third time on the 16th day. Tired from the stress of worry, recovering from surgery, and weakened by chemotherapy, she collected Nan and went, with her other dogs, to a deer camping area close by to try to attract Totsi. At about 3:00 a.m. they heard a rustling noise outside the truck. They didn't want to spook her again, but decided they had to take a chance. Janet opened the truck door and gave a quiet command, "Totsi! Come!" To their amazement and enormous relief, the bedraggled Totsi jumped into the truck.

On the 17th day, a hungry, exhausted, and 18-pounds-lighter Totsi was rescued again - thanks to the dedication and perseverance of these 3 women. And Totsi seems to understand how fortunate she is — she hasn't run away again!

Lennoxville International Sheep Dog Trial

Judge: Ken Price of British Columbia, Canada July 29 & 30, 2000

Maryellen & Dave Young hosted the 8th Annual Lennoxville International Sheepdog Trial on the last weekend in July. The trial is held at Bishops University in Lennoxville, Quebec, which is in the heart of the Eastern Townships region. For the non-Quebecois, the Eastern Townships represents a large area east of Montreal, south of the St. Lawrence, and just above the US border. The countryside is just beautiful, with lush rolling hills and a lot of farms. The towns have a distinctive European flavor.

The trial is held on the athletic fields at Bishops. The course, while flat and smooth, is not easy. The drive was particularly difficult, as there weren't the usual dips or grass tufts to spot off. The Young's Hampshire/Suffolk crosses also added to the test. The dogs needed to apply just the right amount of pressure to keep them together and moving without causing a standoff.



Twelfth Annual NJ State Sheepdog Trials

Fosterfield's Farm, Morristown, NJ Sept. 2 – 4

Twelve years ago the N.J. State Sheepdog Trial was a quiet affair at our farm in Rockaway Township, NJ. We didn't even put together a program for that first trial in 1989. By 1990, it was still a small trial at our farm but we'd graduated to a trial with a program. Here's what I found in that program from 10 years ago: we had a total of 43 entries (3 Novice-Noivce, 7 Pro-Novice, 8 Ranch, 25 Open) and a total of 75 runs (18 on Saturday, 32 on Sunday, 25 on Monday).

In 1991, we moved the trial to Fosterfield's Living Historic Farm in Morristown, NJ. Here's another interesting observation from that year: among the Novice-Novice handlers were Warren Mick, Bernie Armata, Chalmers Means, Barb Armata and Werner Reitboeck. Today those Novice/Novice handlers are all successful Open handlers, and Warren was this year's NJ State Open Champion.

What a far cry from the year 2000, our twelfth year: we had a total of 136 entries (27 Novice-Noivce, 30 Pro-Novice, 23 Ranch, 56 Open) and a total of 261 runs (78 on Saturday, 78 on Sunday, 105 on Monday), all without running to a standard. With a tremendous amount of cooperation from the handlers and volunteers, we finished well before dark every day, and in plenty of time to have a relaxing dinner on Saturday and Sunday nights.

Many thanks to all who helped to make this year's trial a success.

Minutes from NEBCA Meeting on September 2, 2000

Meeting held at Fosterfields Trial

President, Cheryl Jagger-Williams, called the meeting to order at 8:00 PM.

There were 29 members present.

The minutes from the previous meeting on 5/27/00 as published in the summer newsletter were approved.

Warren Mick gave the secretary's report. There are currently 298 members. A preliminary tally of the ballots returned so far on the dissolution / incorporation vote indicates the vote will pass. Therefore, we are officially NEBCA Inc.. A final official count will be given at the next meeting.

Warren is working on the compilation of rules and regulations for trial managers.

Carol Campion gave the open committee report. The fall foliage trial will again be held at the Old Chatham Sheep Herding Company in New York on October 7-8. Ray Edwards will be the Judge. The committee decided that two open placings will be required to qualify. While most of the preparations are in order, there is still a need for two people to work the sheep pen. The pay is \$100 per person for the weekend.

Barbara Armata, speaking for the fund-raising committee, said that the sales of mugs and teeshirts are going well and that over \$2000 has been collected. She said the committee should soon have a better idea of the net profit.

Cheryl noted that a bylaw committee will be formed to address a few issues with the new

bylaws to keep them in line with the changes needed for the incorporation.

We will be determining the actual category we will submit, i.e. educational, social, fraternal, etc. We will need to develop a three year budget and finance plan. We will need to develop a historical record of our budget, etc. for the filing. Cheryl asked if the members would try to help find a tax attorney to help in the filing. Eve Marschark had contacted one in the past and will submit the name to Cheryl.

The Nursery Trials Committee reported about 35 entries have been received for the nursery finals. The finals will be held at Armata's in Esperence, New York on September 16, and 17, 2000. Bruce Smart will be the judge.

The Nominating Committee headed by Betty Levin will be looking for new people for board and executive positions for next year.

The newsletter report from Bill Fosher indicated a newsletter will be out in September. A postal increase next year may cause us some problems. Bill wants to encourage people to submit articles and information for the newsletter and to thank everyone who has pitched in to help with the newsletter this year.

New Business: Cheryl asked for volunteers to help update the web site. Roger and Heather Millen are too busy doing all of the point compilations.

The next meeting will be held at the Fall Foliage trial on October 7.

The meeting was adjourned at 8:15 PM.




