

The annual **NEBCA Fall Foliage**, October 7 & 8, 2000, again took place through the kind hospitality of the Old Chatham Sheep Herding Company in Chatham, NY. This is the fourth year that Old Chatham hosted this event and there are many amenities that came through their generosity. They provided the field and about 90 non-lactating lambs and ewes from their dairy flock. Although these sheep and the course appear at first glance to be simple enough, they are extemely challenging. Old Chatham also provided free of charge the Porto-Let and the bed & breakfast accommodations (fit for a king) for the judge, Ray Edwards.

According to the guidelines, each dog is given two runs and the better of each of these two runs is used to determine the top 10 scores of the qualifying runs. These top 10 dogs then compete in a double-lift run off for Champion & Reserve Champion.

There were 41 qualifying dogs~the first round course consisted of a 400 yard outrun, drive, pen & shed. Difficulty, though, came on the fetches. The better runs boasted good straight fetches and that was not the majority due to wind and heavy pressure. These sheep, as in years past, also proved difficult to pen and shed. The final challenge in the weekend came during the Championship where the highest scoring dogs were those with the best turn-back on the double lift.

Ray Edwards judged the event for the second year. The trials committee was impressed with his judging and asked him back. Once again he brought two high quality crooks for the Champion & Reserve Champion's prizes. The champions were presented these crooks along with engraved silver bowls. Third through 10th place received imported Border Collie window stained glass pieces and all 10 places received ribbons. NEBCA again provided a sweatshirt for all those handlers entered and running at the trial.

Two additional special awards were presented. The first was the Edgar Gould Breeder's Award presented to the breeder of the highest scoring top ten dog that was bred in the NEBCA region; the second, the Long Road Award, to the owner of the highest scoring owner trained dog at the Fall Foliage.

The Breeder's award was presented to Barb Armata who bred Taff. The award itself is a perpetual award. It is a unique wrought iron sculpture that depicts a trial scene and was created by Alexa Jaffurs of Colraine Mass. There is space for ten names to be mounted on the award and Barbara's will top the list. The Long Road award was earned by Ellen Skillings of Colraine Mass for her placing with Paige. Ellen acquired Paige from Tom Wilson at 6 weeks and raised and trained her.

The sheep were evenly spotted throughout the event by Liz Phillips and together with the team of Tanner Millen, Sara Ames and Bill Fosher working the hold-out pen, they performed an excellent job allowing for settled sheep for each run.

Beverly Lambert's Imp.Pippa ABC 153986

Pippa was raised and trained in Scotland by Ian Brownly for whom she won the Scottish Nursery Finals in 1998. After the Nursery Finals she was sold to Bob Shennan where she worked as a hill dog and spent weekends trialing. After her first open season with Mr. Shennan she was purchased by Bobby Ford and brought home to Tennessee. I saw her a few months later, the day after Alasdair MacRae had bought her from Bobby, at Nathan Mooney's dog trial and it was love at first sight. She was just the kind of trial dog I was looking for. She was a clever outrunner, obediant to Bobby's commands, and with plenty of push on the sheep. She was also mine before the weekend was over.

I was very fortunate with Pippa. She had been through a lot of hands by the time I bought her and she was still only 3 1/2 years old. But all of the people who had owned her had been very

wise dog trainers and Pip was a good enough dog to have benefitted from each man's training. Pippa didn't need any training from me, just a period of adjustment while we got used to working together. Our adjustment was slowed down a little bit by Pippa's getting sick with Ehrlichiosis and Lyme disease during the summer. But she made a full recovery by autumn and went on to perform very well at both the Fall Foliage and the National Finals, where she came fifth.

I feel that Pippa and I spent most of last season getting adjusted to each other and getting Pippa over her sickness. I don't think we really got our timing down until about September. So it's with tremendous anticipation that I look forward to trialing with her this year. She is one of the most fun dogs I have ever run. She is very obedient allowing me to put her anywhere on the trial field *Pippa, continued on page 4.*



Ben is at his best when the sheep are heavy and or a bit crazy. He will never loose sheep from the field. Ben's wolf-like presence on the sheep is somewhat threatening, so he has to work the Katahdins at a much greater distance than some dogs. Ben is my best dog at helping with lessons as he will watch as long as needed and merely put the sheep back all on his own, if the youngster working is having some difficulty. He seems to understand whatever situation I put him in and wants to please so badly that he will do anything I ask, to the best of his ability. Ben showed his ability to think and take situations in hand at the Fall Foliage Trial when the sheep I had shed tried to get back to the holding pen past the other sheep. I knew without a doubt that Ben would bring me those sheep from the holding pen right past the other sheep and never let them get together. Someone announced at a trial that I liked this dog so much that I would take another in a minute. I assure you I wouldn't have to think that long.





Beverly Lambert's Imp. Nel ABC 133111

Nel was bred and raised in Wales. When she was a year old she was sold to Andy Carnegie in Scotland where her training was finished and she worked as his principal dog on a large hill farm working sheep and cattle. Nel was very successful in the Scottish Nursery Finals and in her early open career, but about half way through her first open season she began gripping at the pen for no apparent reason. Unable to cure the problem, Andy sold her to Alasdair MacRae, hoping that a change of handler and a different kind of sheep might help her to get over her problem.

I happened to be visiting at Alasdair's when Nel arrived from Scotland. I rather liked Nel the first time I saw her. She was very upset about the trip and very worried but immediately set about trying to get along with everyone present. She wouldn't work the sheep but she was so apologetic about her reluctance to help out that

she had everyone's sympathy. When I saw Alasdair again a few weeks later Nel was working for him a little bit, doing a little gripping but not yet fully committed to being an American dog. Alasdair and I did a little dog trading and he soon had a young dog of mine that I didn't get along with very well and I had Nel. I was concerned about her gripping history but there was something about her refusal to immediately give her heart to the first person that whistled at her that won my respect. I also hoped that perhaps working for a woman in a situation without a lot of hard farm work she might eventually work her way out of the gripping problem.

Nel came home to Connecticut with me in November and went to Texas two months later, where she quite amazed me with her ability to handle the rough range ewes. In the spring she proved more than willing to tackle any type of Beverly Lambert's Nel

sheep I asked her to go up against. If she got in over her head she just grabbed on to the first sheep that went by. She never won a trial that first season, but she always tried 110%. I admired her determination and I felt that the two of us suited each other in spite of our relative lack of success. When she made the top 50 cut at the National Finals in Virginia I was very pleased. When she gripped off on a rushed shed I was not greatly surprised and figured we would give it another year to see if we could get our act together.

This year was our second year together as a team and things have really begun to come together for us. In Texas during January of 2000, Nel performed outstandingly, consistently placing in all of the trials. At home this season

she has been very consistent about placing and even managed to win a few big ones for us. She also is still more than capable of gripping in a tight situation and requires careful handling at the shed, but her driving is excellent and she has a very relaxing effect on sheep that usually tends to make her sheep pretty nice to work. Most of all though I admire Nel for her determination to do what she is asked. No matter how tough the job, she is always there doing her best. She is quicker to go to her teeth than I would like, but I never need to look around for my dog when she is with me; she is always out front doing her very best.

The Transformation of Jill

Border Collies have been in my life 10 years now. Before, I thought what most non-BC people think - the BC is just *NOT* a normal dog! But the traits lying underneath what is a bain for the unknowing draws those who love the breed to it. Sometimes, however, the normal "quirks" of the BC, mixed with a shaky temperament and lack of socialization can be excessive, even for us. So starts the story of my Border Collie, Jill.

Her litter was bred from good working stock and her early weeks were uneventful. But, she showed a clue of future problems when 8-weeks-old. Her breeder placed her on the lawn and Jill curled tightly into a ball and did not move until picked up. She was sold to a pet home and her time was spent between the kennel and training for obedience competition. But by 8 months she wasn't working out; her owner was ready to place her. Being involved in dogs all my life and a student of dog behavior, I adopted her knowing there would be issues with this cute puppy. Our next year together would be an interesting one.

Never mistreated, Jill was fearful, timid, untrusting of people, and terrified of dogs. She would run off avoiding people at all costs. Fortunately, there was little traffic and she eventually came home. Jill tried to avoid petting, acting like a hand-beaten dog. Other dogs sent her diving into nearest hiding place and she arbitrarily lunged and snapped at dogs passing by. She chased and nipped cyclists and joggers and furiously charged our neighbors. Once she even charged a freight train. If any dog could go feral, it was Jill. We nicknamed her "Shark" and I despaired I could live with this dog. Her behavior so bewildered me, I contemplated having her put down, never a decision I take lightly. I have been around many

dogs during my life and been involved in many dog activities; I had *never* seen a dog like Jill.

Drastic measures were needed. I enrolled her into a puppy class for socialization. The dogs and people scared her so I played her favorite game of tug-of-war to distract her. Everyone offered Jill treats and soon she was shyly easing up for the treat. I knew we were making real progress. I kept her on a 30-foot line so she couldn't run off or charge anyone. As she became more trusting of me, and I of her, I could let the line drag the ground and eventually remove it.

Knowing shy, timid dogs often are frightened when touched, I manhandled her. I grabbed and pulled on her during our tug-of-war games. First she wasn't sure but soon got into it. She'd playfully growl and grab my arms and I calmly taught her what "no teeth" meant - mouth but don't bite - finally, no mouthing. My English Springer Spaniel, Oscar, is very precocious and determined Jill would play with him. And play they did. They were equal in their play and soon Jill relaxed, becoming confident, enjoying these times, even instigating the game.

My friends were the best. One has a dog savvy son. Then 11-years-old Michael would run and Jill, always the Border Collie, chased him. Michael quickly told Jill when she had gone too far and she learned to respect him. Michael's friends visited and Jill learned running children don't need chased - best yet, they throw balls!

My friends' dogs were great. We let them loose in the yard or training building and here, Jill learned dogs aren't always a threat. She learned to accept doggie body slams, learned to tolerate puppies and discovered they sometimes need a suitable correction and how to give it. I enrolled her into agility and flyball classes, trained her in obedience and we entered the world of herding. Jill loved it all.

Today Jill is 3 years old and *almost* a normal dog. She confidently goes up to people and, for the most part, matter-of-factly accepts most dogs - wagging her tail. Jill's face is relaxed and open, no longer suspicious and fearful. She's great with kids. This past holiday Jill visited the children at a Christmas party my agency holds attended by over 100 children and had a grand time.

2000 was also our first year of sheepdog trialing. Some of our issues are young dog/novice handler issues, and I continue to work building Jill's confidence on the field. She seems to have some talent and is fast and pushy and sometimes needs to be told to do something twice (a tad hardheaded, 'tis she!). We did take home some ribbons during last season and our trial year culminated by winning the Novice Championship at the Hope's Farm SDT and completing our first Pro Novice course at a VBCA trial.

But, what went wrong with Jill? What made her so fearful? Her breeders have repeated the breeding and those pups are outgoing and friendly. What happened? Do Jill's breeders Continued....

now raise their puppies differently? Did these pups have more early socialization than Jill? Or does Jill just have a genetic wire crossed? Who can say? Jill was lucky. Not that I'm an expert, but I was willing and able to devote the time and effort and had enough knowledge to help her. And I was lucky that the techniques I tried worked - they might not have.

I know Jill isn't that "special dog" the top trialers are looking for, but we're learning a lot together as we move along. Our herding career to this point has been fun and for two rookies, we're doing ok! We'll continue in Pro Novice and hopefully, advance into Ranch this coming season. But, I know no matter how "normal" Jill seems, there's always that shy, timid dog in the background. It now seems, however, she can enjoy life while keeping her demons at bay.

Jill may never be a truly "normal" dog, but what Border Collie is?



Minutes from NEBCA Annual Meeting on January 21, 2001

Pat Canaday's Farm in Altamont, NY

The Vice President, Denise Leonard, called the meeting to order at 11:48 AM. There were 18 members present.

- 1. Denise noted that the quorum requirement of at least 25 members was not met. As a result, no business requiring a quorum could be conducted. Committee reports could be reviewed and discussed but not approved. No motions could be made or considered.
- 2. The secretary reported that there were 326 memberships in 2000. Of these 225 were individual memberships and 98 were family memberships. As of January 21 there were 180 paid up memberships for 2001.
- 3. Joanne Krause went over the Treasurer's report. She showed the accounts payable and accounts receivable summaries for 2000. She also handed out budget summaries for the Novice Finals and Fall Foliage Trials. (These reports are included in this newsletter). As of the annual meeting, there was \$4253.52 in the checking account. The audit for 2000 will be arranged by Jim Strohecker. Joanne recommended hiring an accountant to do the audit this year.
- 4. Barbara Armata gave the fundraising committee report. The fundraising effort in 2000 was very successful. The committee spent \$1633.59 to purchase mugs and tee shirts. The proceeds including the raffle were \$2588.91 giving a profit of \$955.32. Only few items remain unsold. The committee will be soliciting an artwork design for the tee shirt this year. Anyone interested should contact Joanne Krause before the end of March. Barbara also mentioned that more volunteers are needed to help at the sales table at trials.
- 5. Warren Mick discussed report submitted by Joyce Geier on the budget and on non-profit status. The report summarized NEBCA's income and expenditures between the years 1994 and 2000 using numbers provided by the Joanne Krause. This summary was then the basis for the figures in the proposed budget for 2001. (The 2001 budget proposal is included in this newsletter). There are two different categories of non-profit status that could be pursued. One allows for charitable contributions and a reduced postal rates, the second only the reduced postal rates. Joyce recommends the latter as it will be much easier and cheaper to attain.

6. The election and bylaw voting results were given by the secretary.

The Executive Committee will consist of Warren Mick, President; Denise Leonard, Vice President; Maria Mick, Secretary; and Jim Strohecker as Treasurer. The two new Board of Director members are Roger Millen and Kate Collins. The two existing members are Barbara Leverett and Eve Marschark.

Results of Bylaw Questions:

#1 Concerns adding Maryland to the Nebca Region
Total votes cast = 99 (77 for / 22 against)
Votes needed to pass = 66
77 is greater than the 66 required so #1 is passed.

#2 Concerns where NEBCA sponsored events can occur.

Total votes cast = 97 Votes needed to pass = 65 87 is greater than 65 required so #2 is passed.

#3 Concerns participation in NEBCA sponsored events.

Total votes cast = 102 Votes needed to pass = 68 77 votes for option A is greater than the 68 required so option A is passed.

#4 Concerns a wording change to clarify members privileges.

Total votes cast = 95 Votes needed to pass = 64 93 Votes is greater than 64 required so #4 is passed.

- 7. Barbara Leverett gave the board of directors report. She thanked the bylaw committee for the work they did. She then noted that the Board plans to confer lifetime membership status to Walt Jagger at an upcoming meeting.
- 8. The open committee report, prepared by Carol Campion, was given by Warren Mick. (The report is included with this newsletter.)
- 9. The Novice Committee report was given by George Northrup. George noted that the novice trial season went smoothly in 2000. A successful Novice Finals Trial was held at Barb and Bernie Armata's farm with 66 dogs competing. Bruce Smart did the judging. The net cost of the trial to the club was less than \$100.

George noted that less than the usual number of novice dogs had graduated by pointed out of classes. He suggested the reason was that many dogs are being moved up prior to pointing out. George read off the names of those dogs that had graduated in 2000. (The list is included in this newsletter)

- 10. The newsletter report submitted by Lori Cunningham was presented by Warren Mick. The total cost of the Winter issue was \$416.05. A budget of \$4000 was requested for 2001. This will permit printing four regular issues and up to two supplements if needed. Two of the regular issues will be professionally printed and the other two commercially duplicated (like the winter issue).
- 11. The calendar committee report, prepared by Clint Brake, was given by Kate Collins. Expenses for the 2001 calendar were \$3040.00 for printing, \$55 for advertising, and \$72.48 for postage for a total expenses of \$3167.48. Of the 800 calendars printed, 593 calendars have been distributed, 185 remain unsold, and 22 are unaccounted for. So far, \$2714.99 in money has been received with \$326 dollars still due. Discussion followed on whether to do a 2002 calendar. The since about 200 of the 2001 calendars remain unsold the committee was requested to get at least two quotes for printing 600 calendars. Based on the quotes the executive committee and board of directors will decide whether or not to go forward with the 2002 calendar. Kate and Sally are still accepting pictures for the 2002 calendar in the event it is done.
- 12. The issue of pamphlets was discussed. Warren Mick said there are about 100 pamphlets left of the 500 printed in 2000. Steve Wetmore recommended that another batch be printed this year.

13. The library report, submitted by Emily Yazwinski, was presented by Denise Leonard. There were 55 items borrowed in 2000. The library had expenses of \$168.79 and income of \$180. Copies of the 1999 and 2000 USBCHA Finals were ordered and will be available soon. Anyone who has suggestions for new materials the library should purchase should let Emily know.

NEW BUSINESS

- 14. Steve Wetmore suggested a "thank you" to out-going treasurer Joanne Krause for her 6 years of service. Additionally, a "thank you" to Becky Peterson, the outgoing director. Becky has served in various capacities throughout the clubs history.
- 15. Becky Peterson made the announcement that Edgar Gould, lifetime member, could not attend this years meeting due to an injury. A get well card was passed around to send to him from the club. In another announcement, Becky stated that Henry Kuykendahl makes and sells mugs personalized with any picture for \$10. She suggested these would may a nice inexpensive prizes to give out at trials or for other awards.



ZOUK(July 30th 1995-February 13th 2001)

I vividly remember the first time I saw her......Zouk. She was ten months old, frantically hopping up and down, tethered to the end of a three foot chain inside Roger Deschambeault's barn. Her papillon looks struck me. Unhooking her from the chain and leashing her, we walked across the street towards the trial field. Unknowingly, it was to be the first of many such walks together. After an hour or so of sitting with me, Zouk looked calmly into my face. It was then that the connection had been made and our purpose together became evident and accepted by both of us, we were going to learn the sport of herding together.

As a child, we remember our first dog. The one that stayed with you when you were home sick from school or slept at the end of the bed to scare away the childish fears that came with the night. Do you remember your first trial dog? Not your best trial dog, but the one that got you involved in herding, the one that made you want to team up and learn this sport together, when you and this first dog, were both truly novice. The one that helped you to understand what teamwork was all about, that taught you about reading sheep, body language, timing and

patience. This is the dog that taught you all the subtle nuances involved with sheep herding. This is the dog that made you the handler you are today. This was my Zouk.

In the beginning as a novice handler with my first dog, it all seemed so overwhelming, but my mentor helped me learn it step by step. It can't be forced, it is not your will over theirs, but one of a combined partnership and mental connection to accomplish the task at hand. This she taught me.

This past summer when Greg was away, I wanted to train Zouk's pups. With no one to hold out, I asked Zouk to hold the sheep at the far end of the field so the pups in turn could pick them up. So unspoken and yet, she understood what her job was. Once the pup picked up the sheep, Zouk moved to the side and remained at the lower end of the field for further instruction.

How she alone, would go out to our back field, not visible from the barn, and in short time, the flock would round the corner in calm unison, with Zouk elegantly bringing up the rear. She would walk them right into the pen for the night. Once the gate was latched, I would turn around to thank her for a job well done. She would wag then jump up trustingly into my arms, thankful for letting her do what she was meant to do, herd sheep. It struck me at these times, how so very far we had come together and that we understood what each of us expected of the other.

This spring of 2001, diligently, respectfully and lovingly trained, and having worked our way through the ranks of the lower classes, Zouk and I would have entered, for the first time, The Open Class together.

How wrongfully fate stole that from both of us. How, for reasons unclear, fate broke up such a devoted team. Four and a half years together was not nearly enough, and for reasons I will never understand, that was all we were meant to have. But how so very grateful I was to have that time with such a wonderful teacher.

Border Bay Junction Farm has lost Miss Zouk. As magnificently and stoically as she fought over the last five weeks, the unexplained brain disease fought harder. It seemed to take a small piece of her away day by day. Early in the morning on February 12th, after one of her

seizures, which she seemed to be having more of recently, we sat silently on the sunroom floor together, Zouk sleeping peacefully in my arms. It was 6am, twilight, that time that is hard to adequately describe in words.....magical, peaceful, lonely.

Looking out the windows toward the east, the sky was turning a lavender shade of pink as the sun was just about ready to break the horizon line. I looked to the west. The bright, half moon still sparkled amongst the stars in the night sky. Zouk and I, tired and quiet, were in the middle. Somewhere between day and night, light and dark, life and death.

That is when I knew Zouk needed my help.
February 13th, Greg and I held her lovingly as she lay sleeping on her spot on the sun drenched deck, a place she liked to sleep often. With our friend and vet Eve, we released her from her physical pain and sent her spirit to run with her Scottish ancestors.

We already miss her desperately, but are thankful for the time she was in our lives, thankful for her mentoring of me in this sport of herding, thankful for her unconditional love and beautiful, happy face that graced our lives and thankful to see little bits of her in her beautiful pups, Lola, Maya, Vedda and Zeb, her legacy, which we will all do our best to honor as we trial in the future.




