



I had wanted a Border Collie for as long as I can remember. The time was right in my life and I started my quest for a pup. After MANY phone calls and as many turn downs I called Walt. I told him my "story" and asked if he had any pups or planned litters. He said he had a litter due in a few months and suggested my husband and I come up to his

farm for a visit. See the dogs, make sure this was really the dog I wanted.

My husband Paul and drove up and met the man who would indirectly change my life forever! Sheepy Hollow farm was so beautiful to us, so neat as a pin. We met Walt and stepped into his office where the walls were covered in sheepdog rib-We bons.

each sat down and had a cup of Walt's perpetual brew of coffee. We talked about many things as well as dogs.

We then were brought into the barn to meet the dogs. What Paul and I noticed right away was how each dog lived and breathed for Walt, how Walt talked to each one so calm and quiet andhow each dog wiggled and could barely contain itself as he spoke. Walt then asked us if we would like to see them work.

We went out into his field and each dog went to the fence and waited it's turn. Never tied, just went to the fence to wait for it's name. He worked his dogs and as I watched in awe, my world was changing forever. Each dog when done went back to it's spot and the next dog called took it's place. We spent the whole day there. At the end of the day I still remember sitting on a swing chair over by the creek, Walt telling us how much he loved this place. We could see why.

I got my pup from Walt several months later. We just loved that dog. Walt and I spoke often in the months to follow and he mentioned his daughter Cheryl was giving a clinic at his place. He said my pup was just about old enough and suggested we come up. We did and my journey into the sheep-dog world began to unfold and I have never looked back.

Over the years Walt had been a mentor to me on so many

levels. When his Open dog Celt retired from trialing, I painted him a plate of Celt. Over the years I have known him he always mentioned how much he loved that plate. Walt also loved to tell jokes and enjoyed hearing them. Many trials I have memories of sitting in his golf cart and swapping jokes or talking about our runs or dogs or things in

Because of Walt, where I once looked at an open field and thought "wow, I sure would like to ride a horse out there" I now think of nothing else than working a dog on it.

Walt, I could never Thank You enough!





World Trial Competitor Profile: Nancy Obernier (Pennsylvania) By Fiona Robertson

Like most trial enthusiasts in the Northeast, the sport of sheepdog trialing is not a profession for Nancy. In fact, she is a nurse, and currently works with her husband in his business.

"My husband Joe has been extremely supportive, even though he has no

interest in the dog world." Nancy says.

Nancy grew up in the suburbs so has no agricultural background. But she and her husband bought land to raise sheep on and train her dogs, which is located 30 minutes away.

Her first dog was a Border Collie from "Backvard Breeder". That first dog, Nancy muses, had no talent or interest in any of the dog sports and activities that they tried. After dabbling in obedience, flyball and agility and then herding.

Nancy reports that her herding instructor, Steve Paxton-hill said, "I can keep taking your money, but she has no talent."

"At that time" Nancy says, "I was turning 50 and had a mid-life crisis! I didn't want to spend the rest of my life indoors, I enjoyed being outside with the dogs and sheep and with not getting any younger, I decided to take the plunge and get a well bred pup!"

For the short time Nancy had been around herding dogs, she saw novice handlers with dogs that were difficult to handle and train. She made the decision to get an easier dog to work, so she looked around for a repeat breeding and one that would be suitable for a novice handler. My first "real" dog was Del'Mar Ben and came from Dave Ellison in BC, Canada. Ben is by Dave's Imp Jim, a Wisp

son, out of his Imp Nell, who's lines go to Henderson's Sweep and Johnny Wilson's Spot. Ben just turned 7 this year. Nancy says Ben was easy to train up and very biddable.

Nancy also purchased a started dog named Wattie, a bitch whose lines go back to Longton's Bess, from Janet

Beale in Scotland. "Wattie is a wonderful novice dog." Nancy says. "You could send her, turn your back and know the sheep would be at your feet with most of your 50 points intact." Wattie gave Nancy the confidence to progress. Wattie's greatest asset was giving confidence to novice handlers and is now lovingly owned by my good friend Nancy M.

When Wattie and Ben decided they would like to have a litter together (Nancy says Ben broke the door down to get to Wattie), Nick was born. Nick, although from an "oops" litter, is the special dog that Nancy is taking to compete with at the World Trial.

Nick was initially sold as a pup, but Nancy bought him back at a year old, when his owner had a serious accident. "When I got him back he was going around sheep with a good attitude, and I've done all his training since" says Nancy.

When asked who her main mentors in sheepdog handling and training have been, Nancy answers, "Steve Paxton-Hill has been my main mentor, he is great with novice dogs and handlers.

> He will also tell vou when he can no longer help you." At. that point Nancy also did some lessons with Alasdair Macrae when he was in Va. "This is when my handling skills greatly improved." says Nancy.

Nancy also has a lot of support from her friends. Her proudest moment in trialing was having all her friends supporting

her at the National Finals in Gettysburg, "Thank you Dar, Elayne, Fletch, Fran and Nancy M!"

Nancy, like the rest of the NEBCA members going to Wales in September is busy getting her dogs ready. For her, this means making sure that Nick is fit, through both work and running alongside golf cart. Nancy is also hauling sheep to different terrains and fields, and she will be borrowing some flighty sheep to work, as most of Nancy's own sheep are Dorset crosses and require a fair amount of push from the dog.

Words of advice from Nancy: "Watch your sheep, they will tell you everything you need to know." And to those new to trialing, "Enjoy the ride. Don't take yourself too seriously and never train your dog when angry."


Seems like sound advice to me!








World Trial Competitor Profile: Fiona Robertson (Canada)

Initial Interview by Angie Driscoll for www.worldsheepdogtrials.org

A: What is your background? Agriculture? How did you become involved in Border Collies and trialing?

F: Our suburban family never had dogs growing up, only cats. But I was into horses as a kid - did a lot of pony club and showed ponies in the hunter ring well into my teens (I was short enough)! As a teen, a friend of mine had a Border Collie pet dog, which, in

my opinion was the smartest dog I had ever met. As soon as I was living on my own, I went out and got myself a pup. He was from what I would now refer to as a backyard breeder, but his lineage (now that I know a little bit about it!) was decent. One while day, out walking, I met (the now late) Alex McKinven, and I think the first words out of his mouth were "Have ye had 'im on sheep 'tall?"

And so began my pursuit of the sport. Those first five minutes spent 14 years ago with my 10 month old pet Border Collie chasing Alex's sheep around the field evolved into land clearing, barn renovations, fencing, acquiring a small flock of Border Cheviot sheep, more Border Collies, and more land clearing! I think that most people involved at the high level in this sport in the UK would chuckle at our small hobby farm and 20 or 30 sheep, and our day jobs still pay all the bills!

A: Can you tell us something about the first dogs you had and how did these dogs help you advance as a handler?

F: That first dog I had I did a pretty good job of ruining him for trials. He was able to do some very novice tasks, maybe a 100 yard gather and had pretty good balance, but his real talent was for Dog Agility. The first "real" sheepdog was a leftover female pup

from a litter bred by Alex. "Jess" is a granddaughter of JH Wilson's ##Spot and goes back to Templeton's ##Cap on her dam's side. And of course I, in all my great experience to date (next to none!) thought she would be a piece of cake to train and had many visions of winning trials with her. Oh, how she humbled me! Jess was too much dog for a rank beginner, mostly taking matters into her own hands when she

suspected me of incompetence (which was most of the time). We did progress (slowly) to the Open class, and even placed once or twice, but her tight flanks and lack of pace and total disregard for me as her handler didn't allow us to be very consistent! Jess is still with us, now aged 13, as she will always be that first, special dog who taught me many useful things - mostly in a "learn though your mistakes" sort of way!

A: Can you tell us something about the current dogs you have?

F: My two current trial dogs, and the ones accompanying me to Wales in September, are a mother and daughter duo. "Pat", who will be 10 in September, and her 4 year old daughter, "Tap" (yes, lots of thought went into that name!!). I bought Pat from a friend who imported her from Wales with the help of H. Glyn Jones. Her

pedigree contains a lot of the Bwlch lineage and a healthy dose of Price's ##Davy. Pat was everything a novice handler could want, being biddable, stylish and very amiable to live with. She had been trained well all the way up to the shed, which even I, with very little experience was easily able to put on her. She did very well for me through the Novice classes and when we moved into the Open class, she con-

tinued to do well for me, teaching me many things along the way.

"Tap" is out of mv Pat. by Warren Mick's "Glen". Glen is no stranger to NEBCA handlers I am sure! I liked Glen for upright working style, his lovely pace and friendly temperament, and also liked the the way Mick's trained and handled their dogs

that was important to me as well. Tap was a puppy payment for Glen's stud service and it was Warren who trained her up to a very competent Nursery level. But she was meant to be my dog it seems, as I bought her from Warren as a Nursery dog. She is very much like her mother - keen and biddable, with lots of natural talent and loads of style. On the flip side, she tends to be a wide flanker and needs constant confidence building on bold, heavy sheep.

A: What traits do you look for in a dog?

F: The very first thing I want is biddability! After Jess, who did everything at warp speed, slicing her flanks and hardly ever stopping when told, Pat was the first dog with whom I could actually learn how to handle! I also like a very stable and friendly temperament, as I do lots of other ac-

tivities with my dogs as well, such as hiking with packs of friends and dogs.

A: Can you tell us if there has been any person (or people) who has influenced the way you think about, train and/or handle a dog?

F: Obviously I owe most everything to Alex and that gift of that little leftover pup. He also helped a lot with training, taught me about sheep management and was a good friend. Warren Mick and his wife Maria have always opened their home to me when I needed help with training, and I also consider them good friends. Warren helped polish me as a handler. I was always so impressed with his skills to turn someone else's castoff into a useful and even successful dog. To me, that spoke loads for how an open mind can help when training. Beverly Lambert has been (patiently) teaching me the art of shedding, a skill that still seems like Rocket Science to me!

A: When preparing to compete at an event like the World Trial, how do you prepare for this? Do you do anything special or different in training?

F: Yikes! Tap just finished her first season in the Open class, and had puppies this winter, so I find myself in a bit of a

panic! I will take some more (several more, hopefully!) shedding lessons and drive all over creation in search of new and exciting training opportunities to keep my dogs keen and my handling skills alert.

A: What is the best piece of advice you've been given about training or handling a dog?

F: Be fair! I used to get so hot headed running my Jess, when most if not all of the faults in her running were due to my poor training and bad handling!

A: What advice would you give to someone starting out and new to trialing?

F: I think that a well started or trained dog is invaluable to a beginner. But if you do want to train a dog yourself, you'll not necessarily need or want that powerhouse dog that may turn out to be too much to handle for someone new to the sport. A biddable dog, with good natural ability will be your best bet, even if it is a bit on the softer side. And use the novice classes that are offered to learn and grow as a handler, but your goal should be the Open class - maybe with your current dog, or maybe with another.





Now that my first steps into Stock Dog Competition have been taken and I am still here to write this, things are going pretty well. I am learning some pretty important lessons, or perhaps those bits of information others have told me have much more meaning now. Experience is a great teacher.

First lesson, NEVER let your dog watch the sheep being exhausted from the trial field.

I did, and my dog would not set up and focus down the field toward the set-out sheep. She insisted on turning around to

Handlers with younger dogs that needed help with different training scenarios were given opportunities to work in smaller areas with a clinician during the day.



look back at the exhaust. Instantly I knew WHY that point had been made.

After many tries, I finally convinced her she should look up the field and not behind her.

My goal at each trial has been to complete the course without retiring or a DQ. I have competed in three Stock Dog Trials thus far this season and had a score each time. We were not perfect but we did it and walked away with a little more experience.


Setting realistic goals for yourself and your dog each time you

go out to the post is very important. If you expect perfection from the start you will be constantly disappointed. Way too many things can go wrong, bad sheep, bad weather, who knows. I dream of the perfect out-runs, lifts, fetches, drives and pens, hope it happens, but also don't beat myself up when it doesn't. I just have a better idea of what I need to fix when it is all over. So far most of the mistakes are mine to claim.


Each trial has been a wonderful experience, with great people giving me pointers and suggestions on how to improve my training and handling.




