# Massachusetts Sheep and Woolcraft Festival SDT, Cummington

Interesting is not always a good thing. Circumstances outside of the trial managers' control left us with a unmowed hay field for the trial at the Mass. Sheep and Woolcraft Fair in Cummington over the Memorial Day weekend. What this led to was an event more akin to a hunt in the Serengeti than a herding trial as sheep and dogs would become separated visually in the tall grass, only to have the dog pop out and panic the sheep or lose contact and become ineffective in terms of control. There were very few good, controlled runs in any class.

Bud and Mary Ames provided their Katahdin flock. The size of the flock meant limiting the number of runs each day so we started on friday with two go-rounds of PN and one Nov. trial. It quickly became apparent that something needed to be done or there would be little chance of success. We herded the entire flock through the course several times in both directions, providing a somewhat reasonable roadway. The reaction of handlers, really without exception, was very gratifying. Everyone seemed to accept the situation and make the best of it. On Saturday and Sunday there were handlers out walking the course in a group in order to mat the grass down and others harnessed to a cattle panel dragging the drive lines.

We want to thank everyone who participated in this trial for their good humor and forbearance from complaint. For their patience we thank our judges: Bernie Armata, Sue Schoen and Steve Wetmore. A special thanks to Bud and Mary for maintaining equilibrium in the face of what turned out to be quite an ordeal for their sheep. We would also like to thank representatives from Poulin Grain who provided large bags of their Pro-Form dog food to winners in each class. They attended the trial on Saturday and answered questions about their product line.

We apologize for what were really unacceptable conditions and are, of course, concerned that this experience will cause handlers to avoid this trial in the future. We have started, in conjunction with the farmer who owns the field and the managers of the fair, the process of correcting this situation and feel optimistic that we will have a iron-clad guarantee of a mowed field. If this cannot be accomplished we will simply not advertise the trial. On behalf of all the trial managers, Kate Collins, Denise Leonard, Wendy Warner, Martha Walke and myself I ask that you not give up on us.

#### Cascade Farm SDT, 4-6 July 2014

The Cascade Farm SDT trials started with quite a few bangs, loud and close, provided by Mother Nature as an intense thunderstorm passed through the White Mountains on Thursday evening as handlers were arriving. Rain came down heavily throughout the evening and showers continued into Friday. The sheep and dogs appreciated the rain and cool weather as it continued throughout the day. Barbara Armata judged the Novice courses with Bernie Armata judging the Open runs throughout the weekend. Both judges held the handlers to a tough but fair standard.

As part of the mentoring program Novice handlers were paired over the weekend with two Open handlers for a critique of their runs. Denise Leonard graciously videoed each competitors run. The Novice handlers were encouraged to help their dogs find the sheep and were allowed to finish the course even though they were retired.

The sheep were tough, quickly taking advantage of inexperience or hesitation. The drive portion was the undoing of many runs. In Open on Friday there was a tie for second. Maria Amodei and Chris Bowen were evenly matched and chose to break the tie with a toss of the coin and a split of the pot. Friday evening there was a BBQ by Jim, followed by Hatchland's ice cream with homemade brownies and hot fudge sauce.

With better weather Saturday the runs seemed much smoother with more handlers finishing the course and receiving scores. Novice handlers were competing for Champion and Long Road. Open handlers were competing for a slot in the Top 20 Double Lift to be held on Sunday. There were ties for first in both Ranch and Open. Ranch was a three-way between Bernie Armata, Martha Walke, and Molly King. Open was a two-way between Dave Young and Bruce Smart. Each handler and dog ran an outwork course to decide final placing.

On Sunday the top 20 combined scoring handlers and dogs were entered into a Double Lift competition. There were two lifts with 3 sheep each, drive (30 points), pen then a split for 150 points. The majority of the handlers made it all the way through with various techniques being used for a successful shed. For some it was their first double lift and the look-back was hard. Handlers were able to go help their dogs before exhausting their sheep. Maria Amodei with Levi was the Double Lift winner with 148 points losing one point on the outrun and one point on the fetch. Maria Amodei with Song was Grand Champion for the three days and will receive a portrait of Song drawn by Heidi Osgood-Metcalf, www.artofheidiosgoodmetcalf.com . Barbara Levinson with Ryn was Reserve Grand Champion and will receive a Cascade Farm Blanket.

Minutes of the NEBCA Regular Meeting, Cummington Fair Trial, May 24, 2014

- I. Call to order by Warren Mick, President, at 5:50PM
- II. Minutes from the Annual Meeting approved.

#### III. Secretary's Report

As of May, 2014, there are 233 memberships. In 2013, the total number of memberships was 308.

**IV. Treasurer's Report** -- Ellen Rusconi-Black provided an update of the Jan-Apr financial activity. The current total account balance as of 5/27/14 is \$20611.47. Full report posted on NEBCA web site.

# NEBCA Meeting - Cooperstown, NY, August 16, 2014

#### Call to Order:

The meeting was convened by President Warren Mick at 7:13 pm on Saturday, August 16th, at the Leatherstocking Trial site in Cooperstown, NY, with 37 members in attendance.

Secretary's Report: Rose Redick

Martha Walke was not present at the meeting. Membership status: 251 total memberships, 186 individual, 59 farm family, 5 life, 1 honorary.

Treasurer's Report: Warren Mick

Ellen Rusconi-Black was absent but sent a report (see Web site). As of 8/15/14 the total account balance was \$25,884.69. The work to date on the budget shortfall has been very successful. The predicted \$1800 deficit at the time of the annual meeting now looks to be a surplus. Almost \$4000 has been raised in benefit events for the Fall Foliage and Novice Finals. The benefit money will offset the funds NEBCA usually puts into these events. Calendar printing costs are about \$1000 lower than budgeted thanks to the work of Kate Collins and her sister, and Dana Erickson.

**Board of Directors:** Barb Armata said there was nothing new to report.

Nominating Committee - A committee consisting of Dave Sharp, Chair, Mike Nunan, and Barbara Leverett is in place for upcoming election . Four executive positions and two BOD seats are up for election. The terms of directors Lynn Deschambeault and Dave Sharp are up at the end of this year.

Open Trial Committee Report: Rob Drummond Fall Foliage - The FF will be will be in Harper, PA, October 2-5. Entries opened 7/1 and closed 7/31. Currently there are 90 entries, with 8 more received after the closing date. The late entries will be accepted only if there are cancellations. The committee was hoping to keep entries below 85 but is leaning to take all 90 to avoid having a draw. This will allow the trial to be fully sanctioned with the USBCHA. A full list of all entries received before the closing date is published on the NEBCA website. The list is ranked in order of high points. The top 50 dogs will be eligible for the double lift final but this may change if cancellations occur. The cancellation deadline is Sept 1. Currently, the 50th dog has about 100 points. The preliminary trials may be run to a standard if needed in the event of bad weather or unforeseen events. The latest budget for the trial indicates less than \$300 of NEBCA money will be needed.

**High Points Change** - The new high points system went into effect on 8/1/2014. The new system mirrors USBCHA system, counting up to the dog's ten best trials. Gene

Sheninger has implemented the new system and it will be soon available on the web site. He will post a notice on Sheepdog-L when it becomes available.

Novice Trial Committee Report – The novice finals will be at Stonebridge Farm, Gansevoort, NY, September 13-14. Currently there are about 45 entries but anticipate 45-50 by closing date of 9/2 (after the Woolly Winds trial). The important elements of the trial are in place. It is projected that about \$500 of NEBCA funds will be used. This is well below the \$2200 budgeted for the trial. An ABCA promotional grant of \$50 was received.

**Fundraising Committee Report:** Ellen Rusconi-Black reports that fundraising items are selling well Learning Trials Committee: Only \$150 has been provided this year for learning trial events. Mary Thompson is writing an article for newsletter on the impact of the learning trials program from an open handler's perspective.

**Calendar Report:** George Northrop said a few 2014 calendars are left and are \$1 each.

**Library Report:** Martha Walke reported that the library is looking to buy new materials and replace some old items. Lending is slow.

Old Business: There was no old business.

**New Business -** Barbara Levinson said the USBCHA is looking at the East Coast for a finals site for 2015 and 2017. The Belle Grove site is available again. Details will be in the newsletter.

**Adjournment:** Meeting was adjourned at 7:30 pm.

# Hints and Tips for the Trial Field, by Sue Main

Reviewed by Molly King

Hints and Tips for the Trial Field is a very short book that serves as a reference guide to things that may seem obvious to an experienced handler and a mystery solver for the inexperienced handler. For the former, it is a good reminder of what is expected on the trial field in terms of polite behavior and good manners. For the latter it is a primer not only for trial etiquette, but also for how judges judge, how rules came to be and are part of the trialing process.

Sue uses practical language to explain trialing. I like that she cites ISDS guidelines and then explains them clearly, making the book useful for all readers... even including people who are on the sidelines watching skillful handlers and gifted sheepdogs but are not quite sure of the intricacies of what, why, where, and how?

Though we use the USBCHA handbook for our regulations, it is based on the ISDS rules that have been evolving over centuries. Following is the first paragraph in the USBCHA version:

The stockdog trials sanctioned by the USBCHA (HA) are modeled directly after trials in Britain where both sheepdog trials and the Border Collie originated. The "Rules for Trials" and "Notes for the Guidance of Judges" developed by the ISDS are recognized by the HA as the foundation of how HA trials are to be run and judged.

In its version, the USBCHA has attempted to clarify some of the ambiguities found in the ISDS version in order to make judging here as consistent as possible. However, as most of us have learned from trialing, not all judges see things exactly the same way. The HA has attempted to standardize the way trials are judged by providing more detail and specifics on the numerous situations that can occur and how they should be scored. One particularly gray area is the turn around the post, and Sue advises handlers to always ask the judge in the handler's meeting what is wanted or expected.

This small book would be an asset on anyone's bookshelf as a practical reference for trial etiquette as well as the basics of the trial field, explaining in words and in excellent illustrations what is expected of trial participants.

Sue Main has been training, handling and participating in sheepdog trials for over 25 years. She has judged Finals trials in the UK and internationally. She lives in Wales on a farm overlooking the beautiful Bala Lake, the largest natural lake in Wales. At this time, she has about 40 ewes and 30 lambs.

A limited number of copies of "Hints and Tips for the Trial Field" are available at bordercollicsanonymous.com, and the NEBCA library also has the book. It is also available from the ISDS shop on line.

# A Primer on Sportsmanship, author unknown

Sept 17, 1990

As the 1990 trial season winds up I would like to thank all of those who worked so hard to put on trials and keep the whole thing going. Thanks!

Most of the time the sportsmanship and fellowship have been first class.

However, sometimes there are a few among us who take things too seriously and once in a while lose perspective. Here are some things I, as a novice, have learned from the few who have come to take sheepdog trials as ranking just a notch below nuclear war in overall seriousness.

(1) If one ewe splits on ranch run, complain and insist she not be run again.

Don't forget the next class is Open and you could end up with her. Never mind that the dog has just come on like an express train, rattled the sheep, sliced a flank - all at a full gallop - and sent the sheep slamming into a panel. One point which I don't get - if she was so bad that the open dogs couldn't work her, why didn't that ranch dog get a rerun, or at least some bonus points (not unlike the difficulty points in figure skating).

- (2) If the scores are not high enough never let the public think that the dogs are doing anything wrong. This could reflect badly on your image, cut the amount of TV coverage and sneaker endorsements you get next season. Instead go right into action: come off the field, grab the PA and explain to the audience that these are the best dogs in the Northeast, they really can pen the sheep, but the sheep at this trial are not suitably dog broke. Sure, somebody may ask you, "Do they train the sheep as well?" You just have to ignore that question. In fact you probably won't even have time to answer. YOU will have to high tail it out of there before somebody pens the sheep and you look the fool.
- (3) If you need to train your 10-month-old dog, the exhaust area is the best place to do it. Ignore the fact that the trial manager has sent someone out to exhaust sheep with a suitably experienced dog. Just tell him in no uncertain terms that you came here to give this puppy experience, then push on in. Odds are that the other fellow will back down, and then your puppy can chase sheep all afternoon. Maybe not the best training, but your puppy did have a long ride and can use the exercise.
- (4) Sometimes the sheep are not in great or even good physical shape. Never offer to help the sheep crew at 6:30a.m. sorting out the bad ones. Just wait until you are in front of others and tell the guy putting on the trial what you really think. Of course this can hardly be called constructive criticism, but then again you paid your money so fire away.
- (5) If your dog grips, let him hang on. What the heck, the run is already over. Let him get it out of his system. He'll feel more relaxed and the sheep will have learned a lesson for next time. Given the ovine capacity for abstract thought, that ewe will be fully settled for her next time out.
- (6) If you run out of time at the pen, kick the gate when you slam it. This way everybody will know that you wished you had not run out of time.
- (7) Never look things over, decide that you and Fido aren't up to it, and withdraw. Operate under the theory that once you've paid your money you are entitled to: (a) docile sheep that will cover you and your dog's errors; (b) run at precisely the time you prefer; (c) pen the sheep no matter where your dog is or how he behaves; (d) a score over ninety (you'll even take a second or third for every two firsts), and (e) complain aloud with fervor as soon as the thought enters your mind (ignore that fact that some poor S.O.B. has spent \$1,000 and endless hours putting the whole thing together).

I wish I had invented all these behaviors, but I haven't. Anyway, I thought a lighthearted look at the small percentage of poor sportsmanship (and it really is a very small percentage), might be in order.

By the time you read this it will probably be holiday season... may yours be happy.
