Massachusetts Sheep and Woolcraft Fair SDT 2022

The MSWCF SDT was back at the field in Cummington after a two-year hiatus caused by COVID-19. The field was in fantastic shape due to the dry spring, with no standing water anywhere in the field and lovely short grass. The sheep were provided by Heart Stone Farm; they were even and well-behaved allowing for a decent number of scores in each class.

The weather was cooperative with overcast skies on Saturday and occasional light showers for the Novice runs. Saturday night, after the trial finished, there was heavy rain with thunderstorms which heralded cool and dry conditions for Sunday morning. Sunday was sunny and pleasant for the Open runs.

The Judges were Chris Bowen for Novice and George Northrop for Open. Both days went smoothly with outstanding setout done primarily by Peggy Flanagan who kept the sheep marching calmly yet briskly to the setout point.

The South/West Adventures of Gus and Cricket

We headed out on January 1, 2022 from the frigid NE to Florida with Cricket (our small RV). We

stopped at Sherry Lees' in St Cloud, FL to work the dogs on the way to North Port. Kim and Chris Hikes and the Page Farm Trial at the end of January in Georgia. The trial was very well run and the sheep were great. There was a good mix of handlers and dogs. From Georgia we went back to Tennessee, where we have a plot of land, to pick up Gus (our large RV). We then started making our way to Texas.

Our first stop was supposed to be an arena trial in Fort Worth but it was cancelled due to weather so we headed to south Texas to get out of the ice. We went to Seminole Canyon State Park, which is far enough south that it shares a border with Mexico. In fact, we almost ended up accidentally crossing the border into Mexico. We took a wrong turn and had to make a U-turn right in front of the Mexican border with a 40" RV towing a truck. We had to unhook the truck to make the turn. We had quite the audience of border patrol officers watching us.

Can't imagine what they were probably thinking. From Seminole Canyhon State Park we headed to the Fort Stockton trial. It was a great trial and very well run as well. The sheep were range sheep so it was a very challenging course with a big flat outrun and it was very difficult to see the sheep. Each run got better as we went along. Everything in Fort Stockton is prickly and wants to stick to your dog's feet. Booties for the dogs probably would have come in handy.

The trial at Junction was the next stop. This trial is held at an old race tract that had been converted to hold rodeo events. Range sheep were brought in for this trial as well. The bad red dog (ada Barley) spooked a sheep and it lept off the embankement into the water below; considerable effort was required to get her out. Then we stopped at a friend's house in Texas for two weeks and worked dogs. Breaking ice in buckets seemed to be the theme for the two weeks. Texas can actually get quite cold in February. Gaitsville was the last trial for Texas. All of the dogs were improving with the bigger outruns. The sheep were so far away you couldn't really see them. The judge would let you know when the sheep were set. The Texas

trials include a host of extremely good handlers, from the East, West and North. Everybody in Texas was extremely kind and welcoming. Our last stop before heading back to Tennessesse was an arena trial in Yadkinville, NC. We enjoyed the compaony of everyone there and had some nice runs. We then



headed to TN for a few weeks before heading home in Cricket to NY to start the trial season in the Northeast.

NEBCA Spring Meeting

May 20, 2022

(via Zoom)

Meeting called to order 6:04 PM. There were 21 members present. While not a quorum, the meeting continued as there were no items to be voted on. Basic procedures for the meeting were reviewed by Barbara Eriksson.

I. Approval of the minutes for the Annual Meeting were postponed.

II. Executive Committee Reports

A. Secretary's Report (Martha Walke) There are currently 247 members, up from 187 at this time last year. Eighty of these members renewed or joined since the Annual Meeting. There are 7 Life members, 201 Individual members and 39 Farm/ Family members. Of our total membership, 44 are new this year. All current members are renewed or entered in the Points System.

B. Treasurer's Report (Denise Leonard) The report was reviewed by the treasurer. See attachment.

III. BOD Report (Carolyn West)

Since the Annual Meeting in January, the BOD has appointed a committee to review and update the NEBCA By-laws. The members of the Committee are Warren Mick, Dave Sharp and Lori Tsuruda. The Committee had a Zoom meeting on 3/17/22 with Carolyn West and Barbara Eriksson to discuss the Bylaws and to lay out a timeline for the Committee to complete their review. The Committee will send an update to the BOD on or before 5/31/22 and 8/31/22 and will finish their review and present the changes and updates to the Bylaws to the BOD on or before 10/31/22. The BOD will review the changes and present the amended Bylaws to the Club for review and voting prior to the Annual Meeting in 2023.

As a result of the discussion with the Bylaws Committee, the BOD has also reviewed the insurance that NEBCA currently carries. The Bylaws state that the Club will indemnify Directors and Officers of the Club and we wanted to determine if the current General Liability policy provides that coverage. I discussed our General Liability policy and the possibility of adding a policy that specifically indemnifies Directors & Officers (this is call a D&O policy) with our insurance broker and asked her to provide us a quote for D&O coverage. The BOD is discussing the policy and the cost (\$575).

At this time, the BOD has nothing else to report. We are sorry that no BOD members are able to attend the meeting and we welcome any questions regarding both the Bylaws Committee and the additional insurance coverage (send questions to either the entire BOD or to Carolyn).

Discussion followed on what this insurance covers, on 'indemnification' and on the need to make a decision soon concerning this insurance as our current policy is up for renewal at the end of July.

Warren Mick updated the Bylaw Committee's work. They are going through the current Bylaws for 1) updating to reflect current practice(s); 2) changes that need to be made (e. g. change the date for the Annual Meeting in order to do the audit; change quorum requirement; add provisions for online meetings); 3) overall organization and language of the Bylaws to make them clearer and more concise. Their first draft is almost ready for review by the BOD.

IV. Standing Committee Reports

The Committee has a zoom meeting scheduled for Tuesday, May 24th, to begin planning the Fall Foliage Trial.

B. Novice Trials Committee (Pam Wataha) All Novice handlers should double check that their 2022 NEBCA dues have been paid.

Handlers who "begin to trial in Novice classes with any new dog who has previously competed in herding trials with another handler must notify the Novice Trial Committee of the change in handler, and must complete a **Novice Committee Notification Form**. This form may be found as a link on the Novice Guideline page, or by contacting a member of the Novice Committee."

The 2022 Novice Finals will be held in Haverhill, MA, at Tattersall Farm, Sept. 10 &11.

And in other COVID news.....

If you feel fine, but your dog's looking at you funny - trust the dog.

A new study on COVID detection found that trained dogs were actually better at correctly determining an infected person's status in some cases than the typical nose swab antigen tests, according to a paper published Wednesday.

The peer-reviewed work, led by researchers from a French veterinary school and published in PLOS One, is the latest in a long line of research on dogs being used to sniff out COVID. Already they have been used at airports and in concert venues, among other places, to flag potential risk. Researchers sampled 335 adults, both symptomatic and without symptoms. About one-third of them actually had COVID.

Researchers found that the overall sensitivity of the dogs -- correctly giving a positive result for an infected individual -- was 97%, and got all the way to 100% in those who were infected but asymptomatic.

As to specificity -- the ability to correctly diagnose a negative result in an uninfected person -- the dogs were right 91% of the time. "The sensitivity of canine detection was higher than that of nasopharyngeal antigen testing ... but the specificity was lower," the authors wrote. The dogs, a mix of animals from French fire brigades and security dogs from the Middle East, took anywhere from three to six weeks to train.

But don't throw away your test kits; the authors said that while dogs appeared to be highly reliable, PCR tests were still needed to confirm infection, especially for variants.



How did Barb get involved in this crazy obsession called SheepDog Trialing? Well way back in 1974 she was working on a cutting horse ranch when her boss's bitch had a litter and he gave Barb a pup. This was Tara, who was fearless. She could head and heel and knew when to bite and when not to, and could gather the cows and bull off 50 acres by herself. Barb thought this was just normal for a border collie....later she learned how amazing Tara had been. Inspired, she looked for a BC to train and trial, leaving behind her previous passion of horses.

To pay the bills, Barb worked (and worked and worked) as a radiologic technologist. She managed the acquisition of Xrays, ultrasounds, mammograms and CT scans for human patients. Barb and Bernie also built a boarding kennel on their farm to supplement their income. These jobs did limit her ability to travel and train and gain wide-ranging experience with her dogs. Now retired she looks forward to lots more freedom.

I asked Barb what trainers or handlers she admired, and she listed the English shepherd Dave Sykes as a formative influence on her knowledge; lately she has been working enthusiatically with Angie Coker-Sells. Barb has enjoyed a lot of trials over the years, but some of her favorites include Leatherstocking, Caora Farm, Tommy Wilson's, Lone Oak and Millstone (John Campbell) in VA.
