The running order will be drawn and posted the week before the trial.

Entry fees: \$80 for Open, \$55 for Nursery. Please send a separate check for 3rd Open dogs. Checks will not be deposited if 3rd dogs are not allowed. If you pay electronically, your 3rd dog entry fee will be refunded if 3rd dogs are not allowed.
