

GPS coordinates for the trial are 43.44220° N, 72.36089° W Cornish. This is at the dead end of Hilliard Rd. Some GPS software works fine in Cornish but others not so much and cell service is spotty. Some software will try to send you on “roads” around that have not been maintained for 100 years. So here are old style directions:”

From the north:

Take I-91 to the Windsor exit, (#9) go left at the end of the ramp on Rt 5 south. Go about 4 miles into downtown Windsor. At the second traffic light turn left and cross the Cornish Windsor covered bridge. At the stop sign turn right on Rt 12A. In about 1/2 mile take the left fork on Townhouse Rd at the 12% Solution convenience store. Follow directions below from the 12%.

High clearance rigs: Take I-91 to I-89 south. Take the first exit, 12A south (right at the end of the ramp.) Continue on 12A south about 10 miles to Townhouse Rd, a left turn at the convenience store called 12% Solution. Follow directions below from the 12% Solution.

From the west:

Take Rt 11 to I-91 north, or VT 103 to Vt 131 to I 91 exit 8 and follow directions below as if coming from the south.

From the south:

Take I-91 north to the Ascutney exit (#8) and go right at the end of the ramp. Go straight through the first light, cross the Connecticut River and at the next light go left on Rt 12 A.

Go about 5 miles. At the foot of a winding downhill with S curves you'll see the 12% Solution convenience store. Make a sharp right in front of the store onto Townhouse Rd. Then follow the directions below from the 12% Solution.

From the east: go to Claremont NH, take Rt 120 N to Jackson Rd, go left on Jackson and proceed 2.5 mi to a T intersection with Tandy Brook Rd, go right about 5 ft then immediately sharp L uphill on Hilliard Rd. The entrance to the trial venue is to the right at the end of the road, look for signs for parking.

From the 12% Solution:

Go 1.6 miles east on Townhouse Rd. You'll be going uphill and will pass a small covered bridge on the right. After the road levels out, look for a pale

green one-story house on the right and take the right turn 100 yards after it. This is a sharp fall away turn onto a dirt road so it's easy to miss. If the sign hasn't been stolen it says "Tandy Brook and Chase Hi. Rd." If you go too far you'll see a pedestrians only covered bridge on the right.

After turning right on to Tandy Brook Road go just over 1 mile to a 3-way intersection. Bear right up a steep dirt road, Hilliard Rd, which is a dead end. The entrance to the trial venue is to the right at the end of the road, look for signs for parking.
