## **Entry:**

Entries open on September 1, 2025 and close October 6, 2024. Limited entries (50) with wait list. Limit of 2 dogs per handler. If time allows, 3<sup>rd</sup> dogs may be accepted. Please send a separate check. Checks will be cashed and no refunds will be given after October 6, 2024, without veterinary documentation.

## **Trial Rules & Format:**

See the NEBCA website for the updated Fall Foliage rules.

The preliminary will be two open trials over Friday and Saturday. The double lift final will be on Sunday.

Fifteen qualifying teams for the double lift final will be determined as follows:

- The top five scores from first preliminary trial
- Plus the top five not already qualified scores from the second preliminary trial.
- Plus the top five not already qualified combined scores from both preliminary trials.
